rights, if any.

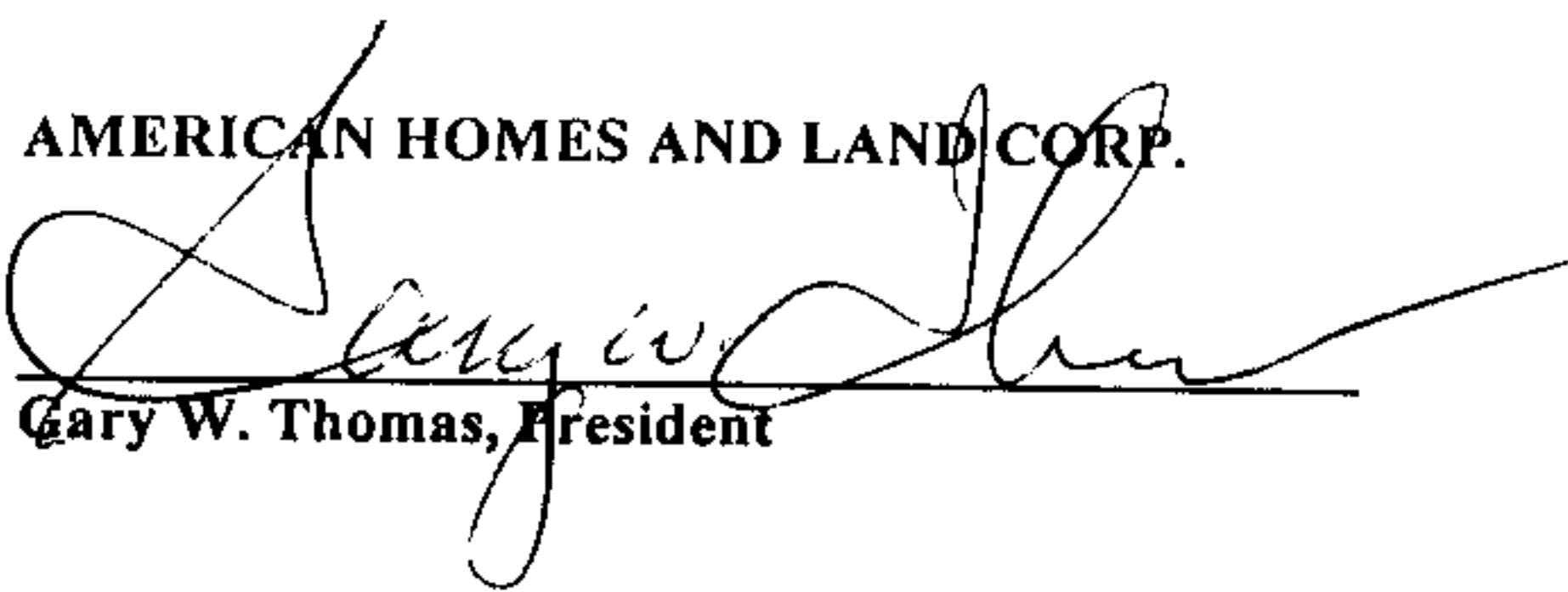

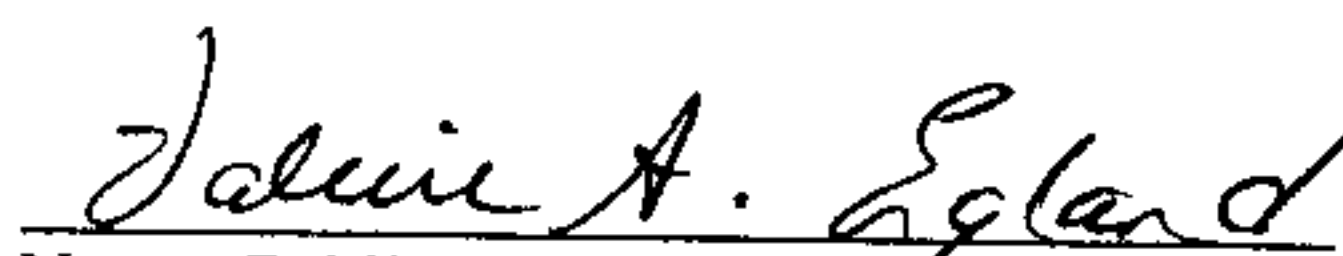
