**KNOW ALL MEN BY THESE PRESENTS**, that in consideration of the sum of Two Hundred One Thousand Three Hundred Fifty and No/100 Dollars (\$201,350.00) the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged **OLD SOUTH BUILDERS, INC.**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **WILLIAM WATKINS & KAREN WATKINS**, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 113, according to the Survey of Lake <sup>FOREST</sup> ~~Crest~~, First Sector, as recorded in Map Book 24, Page 62, in the Probate Office of Shelby County, Alabama.
