**SPECIAL WARRANTY DEED

Cuomo, **SECRETARY OF HOUSING AND URBAN DEVELOPMENT**, of Washington, D.C., for and in consideration of TEN DOLLARS (\$10.00), the receipt whereof is hereby acknowledged, does grant, bargain, sell and convey unto **DANIEL A. HILL and NANCY R. HILL**, as joint tenants, with rights of survivorship, the following described real property, situated in the County of Shelby, State of Alabama:

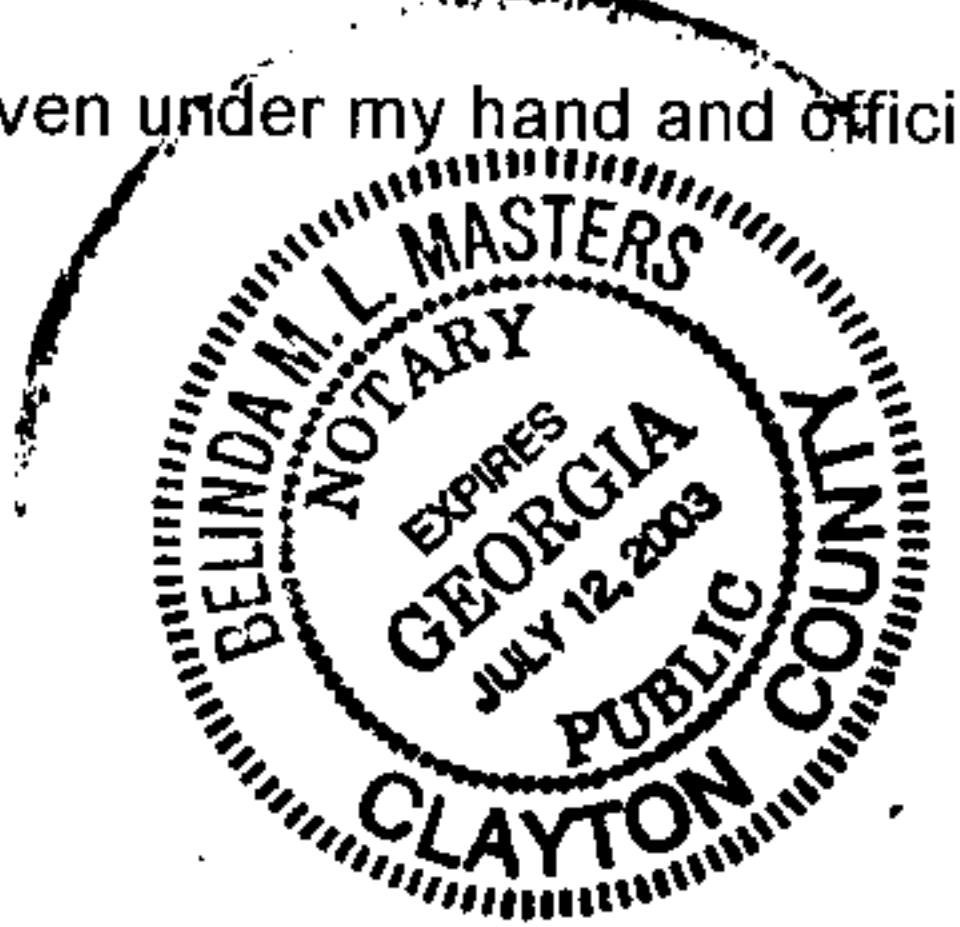
