

# ASSIGNMENT OF MORTGAGE

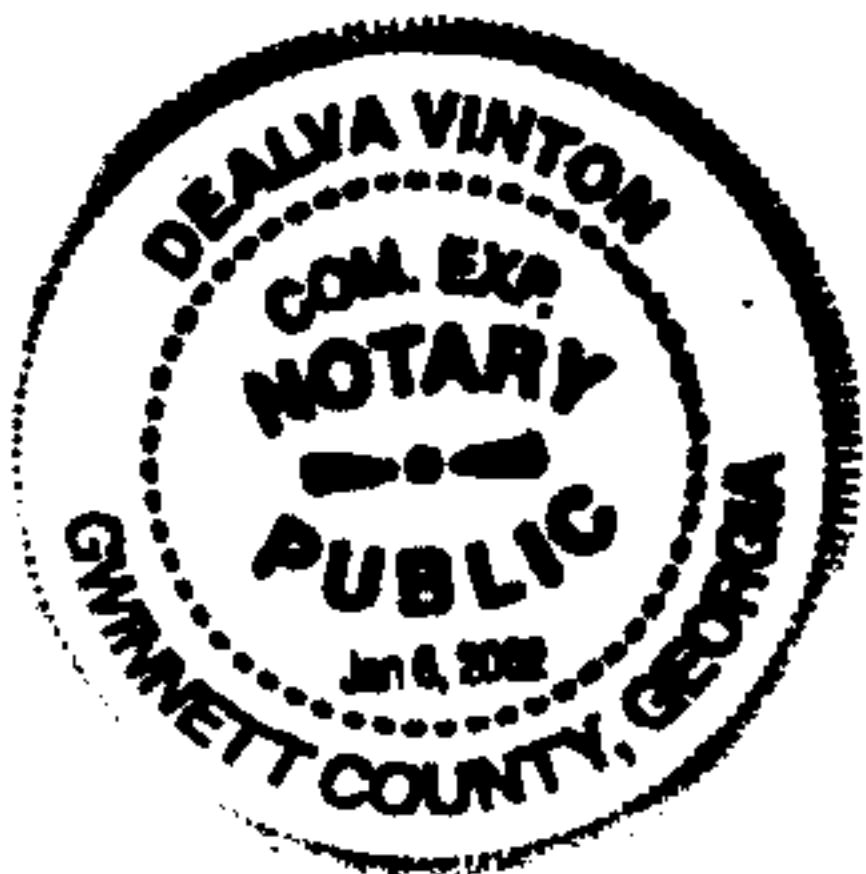
