KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Thousand Five Hundred and No/100 Dollars (\$ 100,500.00) the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged **OLD SOUTH BUILDERS, INC.**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **JERRY S. HUGHES & MELISSA R. HUGHES**, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, the following described real estate situated in Shelby County, Alabama, to wit:

Lot 303, according to the Survey of Camden Cove, Sector 1, as recorded in Map Book 25, Page 33 A, B & C, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 2001 and subsequent years not yet due and payable.


\$97,400.00 of the purchase price recited herein was paid from proceeds of a mortgage loan closed simultaneously herewith.

IN WITNESS WHEREOF, the Grantor has signed and sealed this Deed on the 29th day of November, 2000.


