**WARRANTY DEED AND LIMITED POWER OF ATTORNEY**

**KNOW ALL MEN BY THESE PRESENTS:** That in consideration of One Hundred Eighty Six Thousand Nine Hundred Dollars and no/100----- (\$ 186,900.00 ) to the undersigned Grantors in hand paid by the Grantees, whether one or more, herein, the receipt of which is hereby acknowledged, we, **Robert F. Norton, Jr. and wife, Denise J. Norton** (herein referred to as Grantors) do grant, bargain, sell and convey unto John T. Haskew and wife, Barbara R. Haskew (herein referred to as Grantees) as individual owner or as joint tenants, with right of survivorship, if more than one, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:
