**MEMORANDUM OF AGREEMENT**

The Memorandum of Agreement is entered into this day of Oct. 13 2000, by and between American Tower L.P., a Delaware limited partnership, with an office at Galleria 75 Office Park, 3200 Cobb Galleria Parkway, Suite 205, Atlanta, GA 30330 (hereinafter referred to as "LICENSOR") and Nextel South Corp., a Georgia corporation, d/b/a Nextel Communications, with an office at 6575 The Corners Parkway, Norcross, GA 30092 (hereinafter referred to as "LICENSEE").

1. THE LICENSOR entered into a License dated October 13, 2000 pursuant to that certain MASTER TOWER SPACE RESERVATION AND LICENSE AGREEMENT dated November 16<sup>th</sup> 1999 ("LICENSE"), for the purpose of licensing space on THE LICENSOR'S communications tower located on the real property described in Attachment A hereto and installing associated communications equipment thereon.
2. The term of the LICENSE is for five (5) years commencing on December 1 2000 and ending on December 1 2005 with seven (7) successive three (3) year options to renew. If all options to renew are exercised, the term of the LICENSE will expire twenty six (26) years after the License Commencement Date (as defined in the LICENSE).

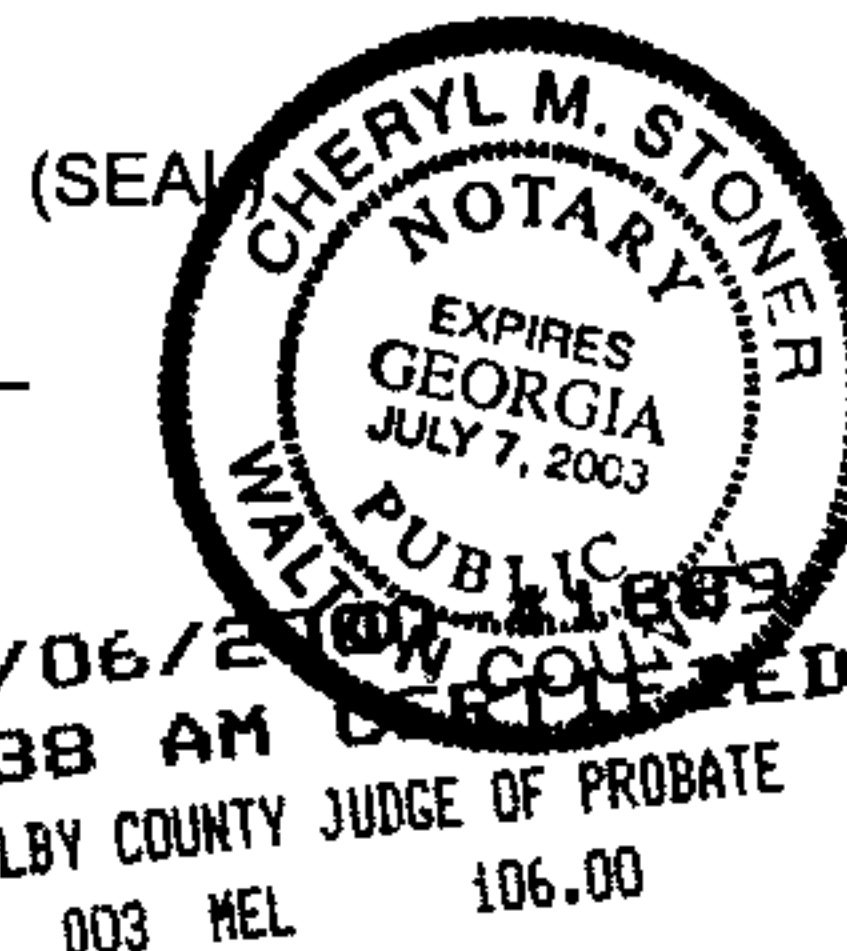

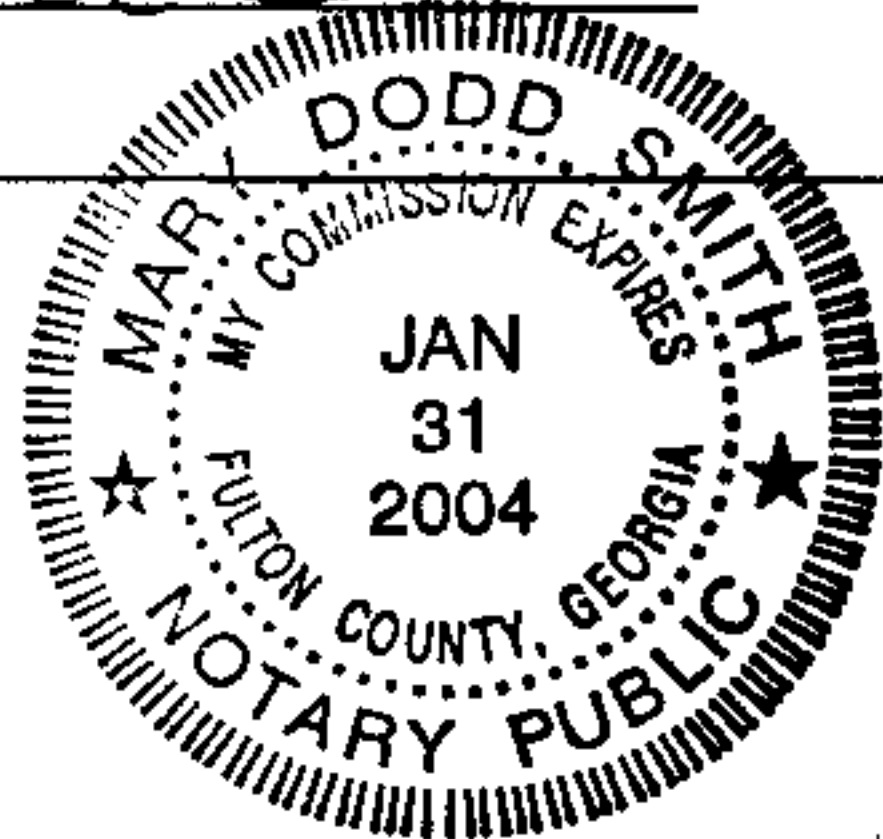
