See Attached Exhibit A.

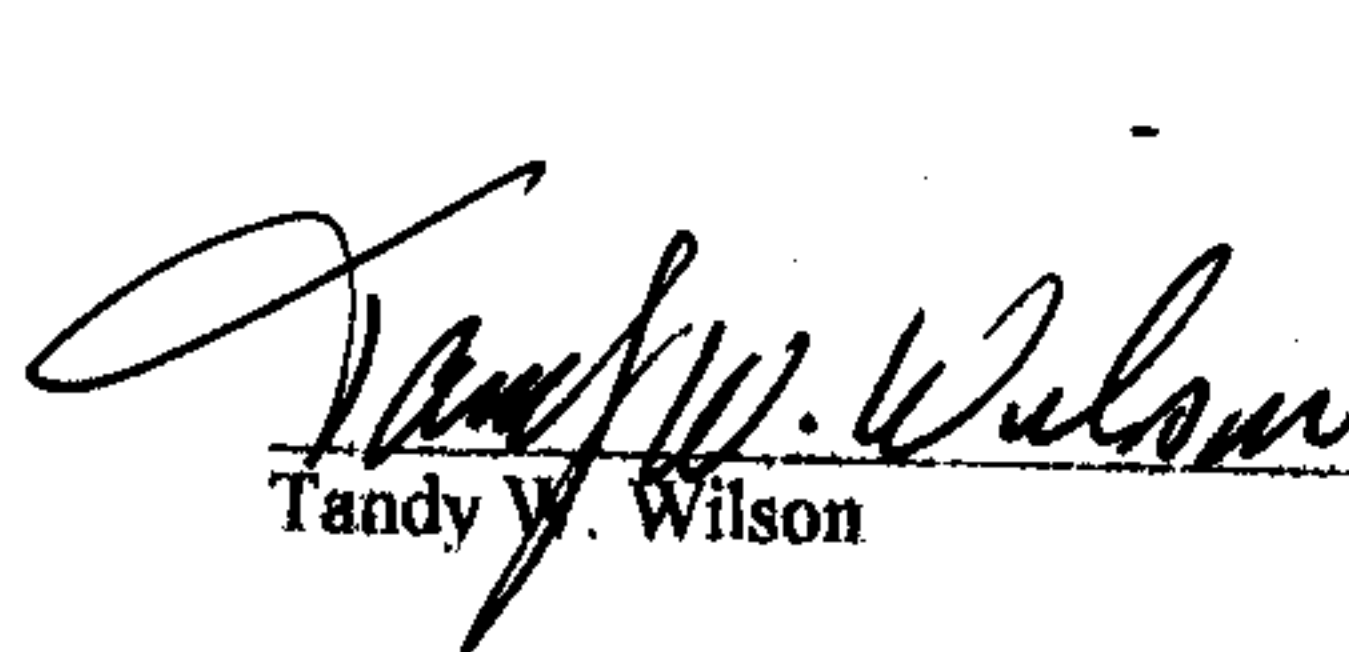
