KNOW ALL MEN BY THESE PRESENTS, That, I, PHYLLIS GILES REITMEYER, a resident of Jefferson County, Alabama, being over the age of nineteen (19) years and of sound mind and disposing memory, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking all other wills and codicils heretofore made by me.

FIRST: I do hereby direct that all of my just debts, including the expense of my last illness and funeral, be first paid by my Executor, hereinafter named, out of my estate as soon as is practical after my death.

SECOND: I hereby give and bequeath unto my beloved son, HARRY ARTHUR REITMEYER, JR., the sum of Ten Thousand Dollars (\$10,000.00) having already given a similar sum prior to the execution of this Will to my beloved daughter, KATHERINE REITMEYER ABBOTT. I give my Executor, hereinafter named, the authority to divide and distribute the contents of my said home as in his best judgement he deems proper.

THIRD: The residue of my estate, both real and personal, that I may own or have any interest in at the time of my death, shall be divided by my Executor, hereinafter named, into two equal shares, and distribute as follows:

1. One share is to go to my beloved son, HARRY ARTHUR REITMEYER, JR.
2. One share is to go to my beloved daughter KATHERINE REITMEYER HIDALGO.

FOURTH: I hereby give to my Executor, hereinafter named, the power to sell or dispose of any of my property, real or personal, that to him seems desirable, during his term as Executor without the necessity of obtaining approval of any Court or person.

In the event that HARRY ARTHUR REITMEYER, JR., predeceases me or fails or refuses to act as Executor, then I do hereby nominate, constitute and appoint my daughter, KATHERINE REITMEYER HIDALGO to be the Substitute Executrix under the same terms and conditions as above.

I, PHYLLIS GILES REITMEYER, the Testatrix, sign my name to this instrument this 28 day of August, 1991, and being first duly sworn, do hereby declare to the undersigned authority that I sign it willingly, that I execute it as my free and voluntary act for the purposes therein expressed, and that I am nineteen (19) years of age or older, of sound mind, and under no constraint or undue influence.
