Know All Men by These Presents: That in consideration of **One Hundred fifty five thousand and NO/100 (\$155,000.00)DOLLARS** to the undersigned grantor, A Corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Heatherbrooke Construction Company, INC.** Corporation, (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Christopher D. Rainier and Melissa Rainier**, (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in SHELBY County, Alabama, to-wit:

\$139,410.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.

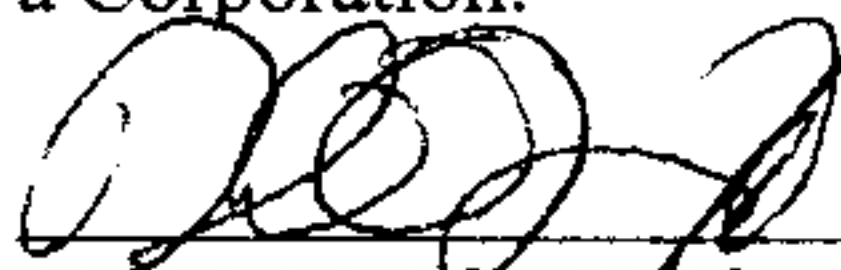

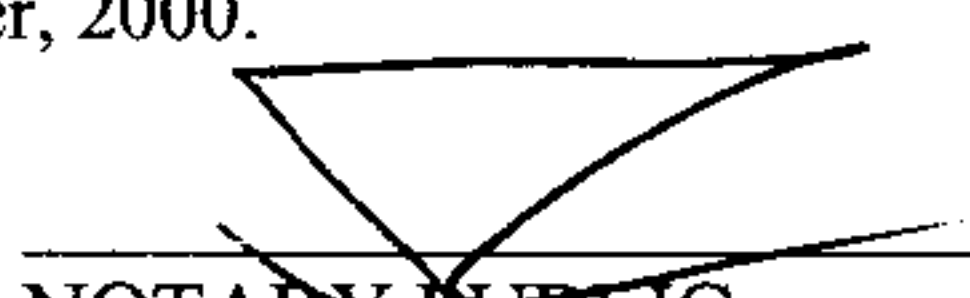
