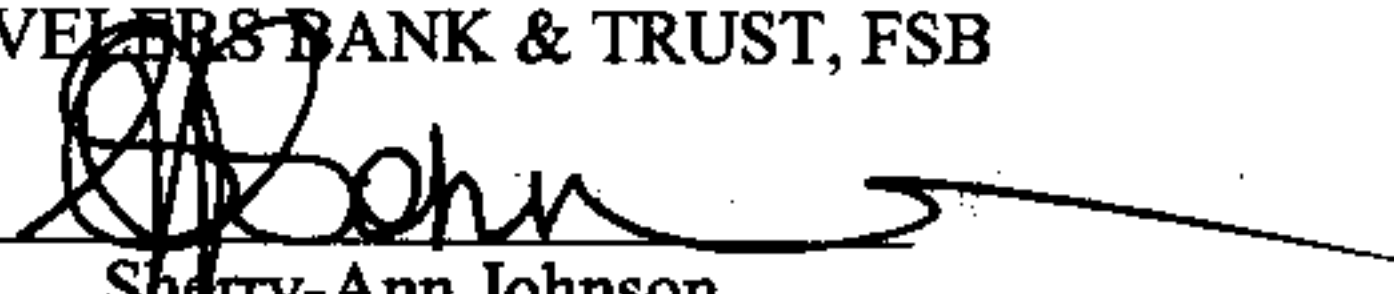

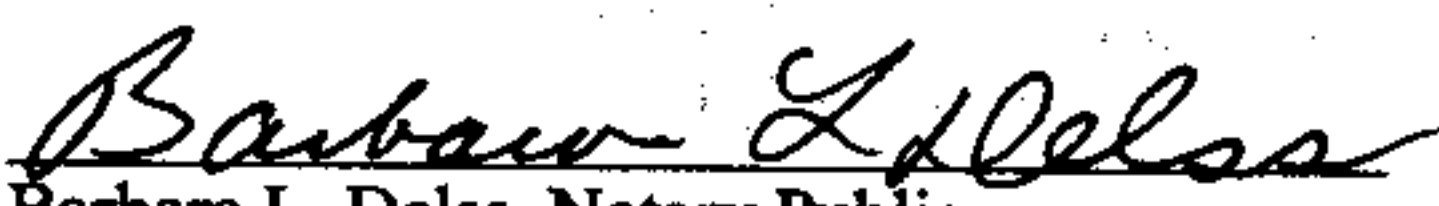

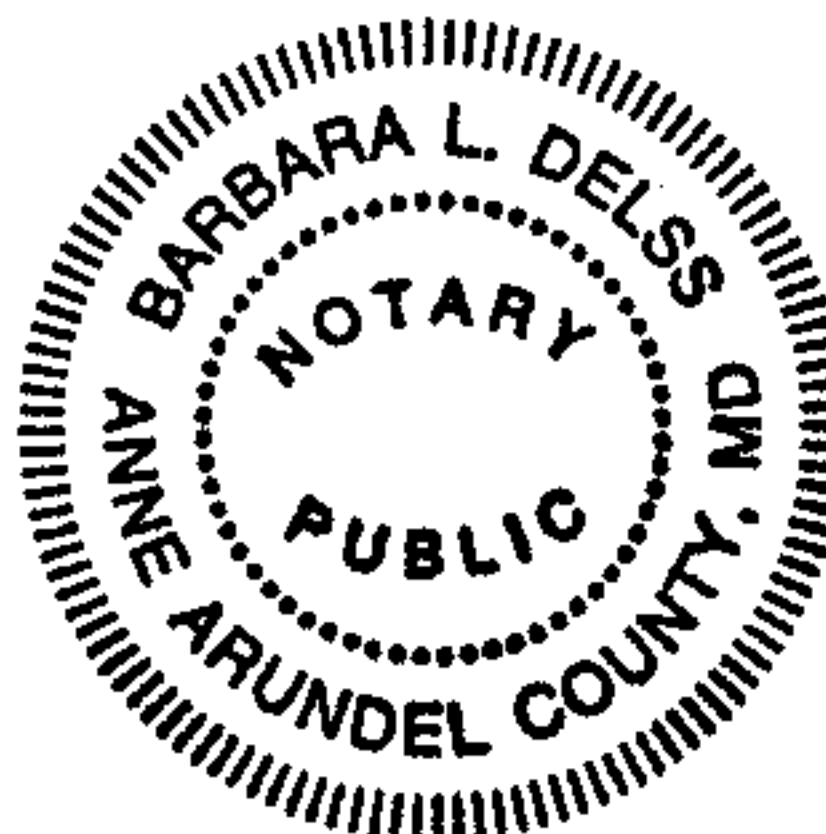

BEGIN AT THE NORTHWEST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 18, TOWNSHIP 20 SOUTH, RANGE 3 WEST, THENCE RUN EAST ALONG THE NORTH BOUNDARY OF SAID QUARTER QUARTER A DISTANCE OF 529.58 FEET TO THE CENTERLINE OF AN OLD ROAD; THENCE TURN RIGHT 25 DEGREES 40 MINUTES SOUTHEASTERLY 113.04 FEET ALONG THE CENTERLINE OF SAID ROAD TO THE P.T. OF A CURVE; THENCE TURN RIGHT 04 DEGREES 33 MINUTES SOUTHEASTERLY 166.0 FEET ALONG THE CENTERLINE OF SAID ROAD; THENCE TURN RIGHT 10 DEGREES 42 MINUTES SOUTHEAST 166.0 FEET; THENCE TURN 10 DEGREES 42 MINUTES SOUTHEASTERLY 75.14 FEET TO A POINT ON SAID OLD ROAD; THENCE TURN RIGHT 87 DEGREES 59 MINUTES SOUTHWESTERLY 40.0 FEET TO A POINT OF BEGINNING; SAID POINT ON THE WESTERLY RIGHT OF WAY OF SAID ROAD, THENCE PROCEED ON PREVIOUS COURSE 211.17 FEET; THENCE TURN LEFT 84 DEGREES 33 MINUTES SOUTHEASTERLY 208.80 FEET; THENCE TURN LEFT 95 DEGREES 27 MINUTES NORTHEASTERLY 210.00 FEET TO THE SAID WESTERLY RIGHT OF WAY; THENCE TURN LEFT 81 DEGREES 18 MINUTES NORTHWESTERLY 119.14 FEET ALONG RIGHT OF WAY; THENCE TURN LEFT 06 DEGREES 41 MINUTES NORTHWESTERLY 90.88 FEET TO THE POINT OF BEGINNING, SITUATED LYING AND BEING IN SHELBY COUNTY, ALABAMA.
