KNOW ALL MEN BY THESE PRESENTS: That in consideration of Two Hundred Ninety Six Thousand Five Hundred Dollars and no/100----- (\$ 296,500.00) to the undersigned Grantors in hand paid by the Grantees, whether one or more, herein, the receipt of which is hereby acknowledged, we, Daniel P. Wilms and Anne M. Wilms, husband & wife, (herein referred to as Grantors) do grant, bargain, sell and convey unto Isaac V. LaSalle, an unmarried man, and Margaret W. Johnson* (herein referred to as Grantees) as joint tenants, each an undivided ½ interest, if more than one, the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:

Lot 6, according to the Survey of Park Lane Addition to Riverchase, as recorded in Map Book 11, Page 17, in the Probate Office of Shelby County, Alabama;

And we do for ourselves and for our heirs, executors, and administrators covenant with said Grantee(s), his/her/their heirs and assigns, that we are lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that we have a good right to sell and convey the same as aforesaid; that we will and my heirs, executors and administrators shall, warrant and defend the same to the said Grantee(s), his/her/their heirs, and assigns forever, against the lawful claims of all persons.



This power of attorney shall not be affected by disability, incompetency or incapacity of Principal, and shall be governed by the laws of the State of Alabama. This power of attorney is coupled with an interest and shall remain in force and effect until delivery of this deed and the sale closed, and shall not be revoked by either of the undersigned prior to said time.
