# ARTICLES of ORGANIZATION of Material & Plan Services, L.L.C.

Pursuant to the Provisions of Act No. 93-724 of the Alabama Legislature, ~~the undersigned hereby adopt the following~~ LIMITED LIABILITY COMPANY ARTICLES of ORGANIZATION:


