

ARTICLES OF ORGANIZATION

OF

THE TOTAL LOOK, L.L.C.

Pursuant to the Provisions of the Code of Alabama, Title 10, Chapter 12, Article 1, et. seq., the undersigned hereby adopt the following limited liability company Articles of Organization:

ARTICLE I

The name of the limited liability company is: The Total Look, L.L.C. (hereinafter referred to as the "Company").

ARTICLE II

The period of duration for the Company is perpetual, beginning from the date these Articles of Organization are filed in the Office of the Judge of Probate of the county in which the initial registered office of the Company is located.

ARTICLE III

The purpose or purposes for which the Company is organized is the transaction of any and all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Act, including, but not limited to, any and all transactions which are necessary, appropriate or incidental to the operation of a beauty salon.

ARTICLE IV

ARTICLE VI

The Company shall be managed by its members as provided in the Operating Agreement of the Company.

ARTICLE VII

The initial members of the Company shall have no right to admit additional members, except in accordance with the Operating Agreement of the Company, as amended from time to time.

ARTICLE VIII

The cessation of membership of one or more members will result in dissolution of the Company except when there is at least one remaining member and all remaining members consent in writing to continue the legal existence and business of the Company within 90 days after such a cessation of membership in accordance with the Operating Agreement of the Company.

ARTICLE IX

All other provisions for the regulation of the internal affairs of the Company shall be set out in the Operating Agreement of the Company, as amended from time to time, and shall be in compliance with the Alabama Limited Liability Company Act.
