## **ORDINANCE NUMBER 00U**

**COUNCIL MEMBER ANDERSON INTRODUCED THE FOLLOWING ORDINANCE.**

**COUNCIL MEMBER BROWN SECONDED THE ORDINANCE.**

### **AN ORDINANCE ASSENTING TO CERTAIN PETITIONS FOR ANNEXATION**

**WHEREAS, all of the owners of property located and contained within an area contiguous to the corporate limits of Montevallo, and not within the corporate limits or police jurisdiction of any other municipality, have signed and filed written petitions with the City Clerk requesting that such property or territory be annexed to Montevallo, and**

**WHEREAS, said petition contains an accurate description of the property or territory proposed to be annexed together with a map of the said territory showing its relationship to the corporate limits of Montevallo,**

**BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF MONTEVALLO, ALABAMA, AS FOLLOWS:**
