## RIGHT-OF-WAY DEED FOR PUBLIC ROAD

## STATE OF ALABAMA COUNTY OF SHELBY

KNOW BY ALL MEN BY THESE PRESENTS, That we, the undersigned, GULF STATES

PAPER CORPORATION of the County and State of aforesaid, in and for the consideration of

Ten and WD/100 Dollard

in hand paid by Shelby County the receipt whereof is hereby acknowledged and for the further consideration of the benefit accruing to us and to the public from the construction or improvement of a public road through our lands, in Shelby County, do hereby give, grant, bargain, sell and convey unto Shelby County, its successors or assigns, a Right-of-Way hereinafter described, over and across our said lands in Shelby County, Alabama, for a public road; which Right-of-Way shall be SIXTY(60) feet in width, THIRTY (30) feet each side of the centerline of said road, as it is now located and staked out by the Highway Department or an much of our lands as is required to make an SIXTY (60) foot right of way across our lands, said Right-of-Way herein conveyed being more particularly described as follows, to-wit:

#### PARCEL I

A Parcel of Land situated in Section 4, Township 24 North, Range 15 East, Shelby County, Alabama, being more particularly described as follows:

Commence at a railroad spike found locally accepted to be the Southeast corner of said Section 4; thence run North along the East line of said Section 4 for a distance of 166.44 feet to a point on the centerline of Shelby County Highway No. 46, also being the point of beginning; thence continue along last stated course for a distance of 2,287.88 feet to the Northeast corner of the Southeast quarter of said Section 4; thence turn an angle to the left of 94 degrees, 49 minutes, 31 seconds and run in a Westerly direction along the North line of the Southeast quarter of said Section 4 for a distance 60.21 feet to a point; thence turn an angle to the left of 85 degrees, 10 minutes, 29 seconds and run in a Southerly direction 60 feet from and parallel to the East line of said quarter Section for a distance of 2,276.67 feet to a point on the centerline of Shelby County Highway No. 46, said point being on a curve to the left having a central angle of 01 degree, 36 minutes, 07 seconds and a radius of 2,157.15 feet; thence run in an Easterly direction along the centerline of said Highway No. 46 and also along the arc of said curve for a distance of 60.32 feet to the point of beginning. distance of 134.65 feet to a point on the North line of said Section 3; thence turn an angle to the left of 120 degrees, 30 minutes, 16 seconds and run in a Westerly direction along the North line of said Section 3 for a distance of 69.64 feet to a point; thence turn an angle to the left of 59 degrees, 29 minutes, 44 seconds and run in a Southwesterly direction for a distance of 84.22 feet to a railroad spike found; thence turn an angle to the right of 28 degrees, 13 minutes, 00 seconds and run in a Southwesterly direction for a distance of 119.53 feet to a railroad spike found; thence turn an angle to the right of 07 degrees, 32 minutes, 10 seconds and run in a Southwesterly direction for a distance of 274.72 feet to a point; thence turn an angle to the right of 10 degrees, 46 minutes, 11 seconds and run in a Southwesterly direction for a distance of 122.81 feet to a point; thence turn an angle to the right of 13 degrees, 21 minutes, 33 seconds and run in a Northwesterly direction for a distance of 59.14 feet to a railroad spike found; thence an angle to the right of 11 degrees, 03 minutes, 42 seconds and run in a Northwesterly direction for a distance of 75.39 feet to a railroad spike found; thence turn an angle to the right of 06 degrees, 55 minutes, 45 seconds and run in a Northwesterly direction for a distance of 201.15 feet to a rebar found; thence turn an angle to the left of 07 degrees, 44 minutes, 29 seconds and run in a Northwesterly direction for a distance of 159.82 feet to a 1" crimped iron found; thence turn an angle to left of 10 degrees, 48 minutes, 44 seconds and run in a Southwesterly direction for a distance of 278.80 feet to a point; thence turn an angle to left of 02 degrees, 21 minutes, 13 seconds and run in a Southwesterly direction for a distance of 464.71 feet to a 1" crimped iron found; thence turn an angle to the right of 01 degree, 54 minutes, 26 seconds and run in a Southwesterly direction for a distance of 186.23 feet to a 1" crimped iron found; thence turn an angle to the right of 00 degrees, 17 minutes, 21 seconds and run in a Southwesterly direction for a distance of 220.16 feet to a point; thence turn an angle to the left of 08 degrees, 49 minutes, 03 seconds and run in a Southwesterly direction for a distance of 544.44 feet to a point on a curve to the left having a central angle of 73 degrees, 53 minutes, 18 seconds and a radius of 528.34 feet; thence run in a Southwesterly direction along the arc of said curve for a distance of 681.35 feet to the point of beginning. Said Parcel III containing 7.15 acres, more or less.

To have and to Hold by Shelby County, or its Assigns, and for and in consideration of the benefit to our property by reason of the construction or improvement of said road, we hereby release the County aforesaid, and all of its employees and officers, and the State of Alabama and all its employees and officers from all consequential damages, present or prospective, to our property, arising out of the construction, improvement, maintenance or repair of said road, and that said road is a benefit to our property is hereby admitted and acknowledged. All agreements, covering the moving, relocating and/or changing of the building and/or structures located wholly or partially on the above described Right-of-Way shall be in writing and approved by the State Highway Department before same shall be valid and binding on the said State Highway Department. The grantor hereby grants permission with right of ingress and egress to grantor's adjoining property at any time during construction period of project for the purpose of moving grantor's buildings and/or structures from the above described Right-of-Way.
