**WARRANTY DEED, JOINTLY FOR LIFE
WITH REMAINDER TO SURVIVOR**

KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of **One Hundred Nineteen Thousand Five Hundred and 00/100 Dollars** (\$119,500.00) to the undersigned GRANTORS in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, **Bethel L. Wheeler, Jr. and Diane D. Wheeler, husband and wife** (hereinafter referred to as GRANTORS), do hereby grant, bargain, sell and convey unto **L. Kevin McCormick and Wendy Q. McCormick, husband and wife** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in the County of **Shelby** and State of Alabama, to-wit:

Lot 60, according to the Survey of Dearing Downs, Ninth Addition, Phase I, as recorded in Map Book 11, Page 87, in the Probate Office of Shelby County, Alabama.



This conveyance is hereby made subject to restrictions, easements and rights of way of record in the Probate Office of Shelby County, Alabama.
