6 aka Karen Mary Jones; Brian D. Magee, aka Brian Stewart Magee,
7 aka Brian Magee judgment in the principal sum of \$258,976.71,
8 plus attorneys' fees in the sum of \$5,473.55, plus costs of suit
9 incurred in the sum of \$534.00, plus any additional attorneys'
10 fees incurred herein pursuant to California Code of Civil
11 Procedure § 685.040.

13 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that
14 plaintiff, Phoenix Leasing Incorporated, is entitled to
15 possession of all personal property of defendant Voyager
16 Investments Co., Inc. to wit: the personal property listed on
17 Exhibit A and Exhibit B attached hereto and incorporated herein
18 by this reference as though set forth in full (the "Personal
19 Property").

21 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that
22 Plaintiff may sell the Personal Property in a commercially
23 reasonable manner in accordance with the California Commercial
24 Code, and in particular, in accordance with California Commercial
25 Code § 9504. The net proceeds of such sale, after deduction of
26 reasonable expenses of retaking, holding, preparing for sale,
27 selling and the like, shall be applied to the judgment.

7 possession of the Personal Property.

10 Investments Co., Inc., turn over said property to Phoenix Leasing
11 Incorporated, at its offices, located at 2401 Kerner Blvd., San
12 Rafael, California 94901.
