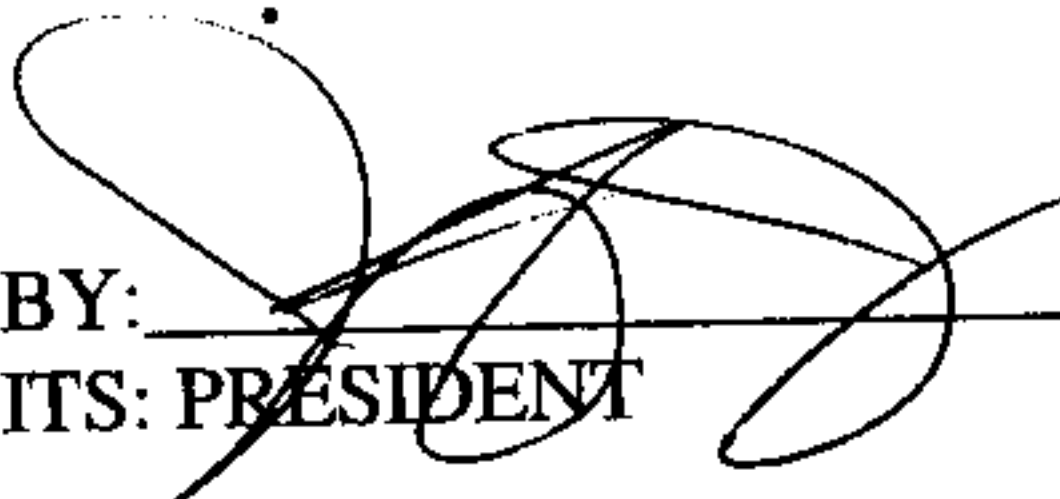
1. Advalorem taxes for the current tax year, 2001.

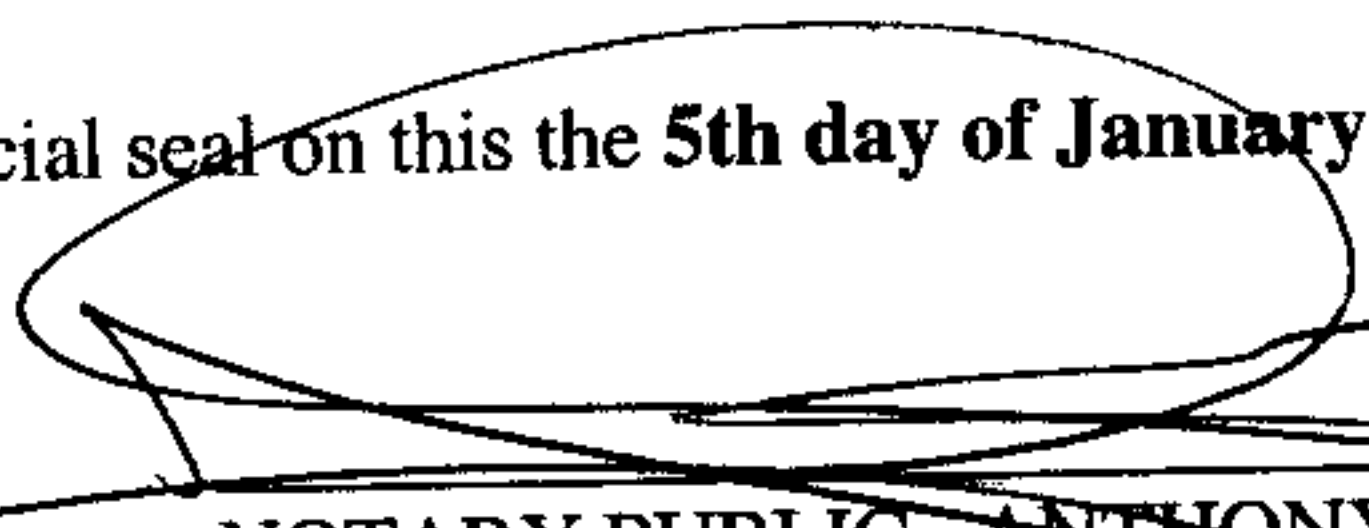
