

## SPECIFIC POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS, that I, PATRICK G. SMITH, a legal resident of the State of ALABAMA, have this day made, constituted and appointed and by these presents do make, constitute and appoint KIMBERLY L. WILLIAMS my true and lawful attorney in fact, and in my name to act as follows:
