ALABAMA FOREST PRODUCTS, INC. agrees to install all culverts as it deems them necessary.

ALABAMA FOREST PRODUCTS INC. agrees to leave pre-existing roads in a condition such that they are negotiable by a two-wheel drive pick-up truck.

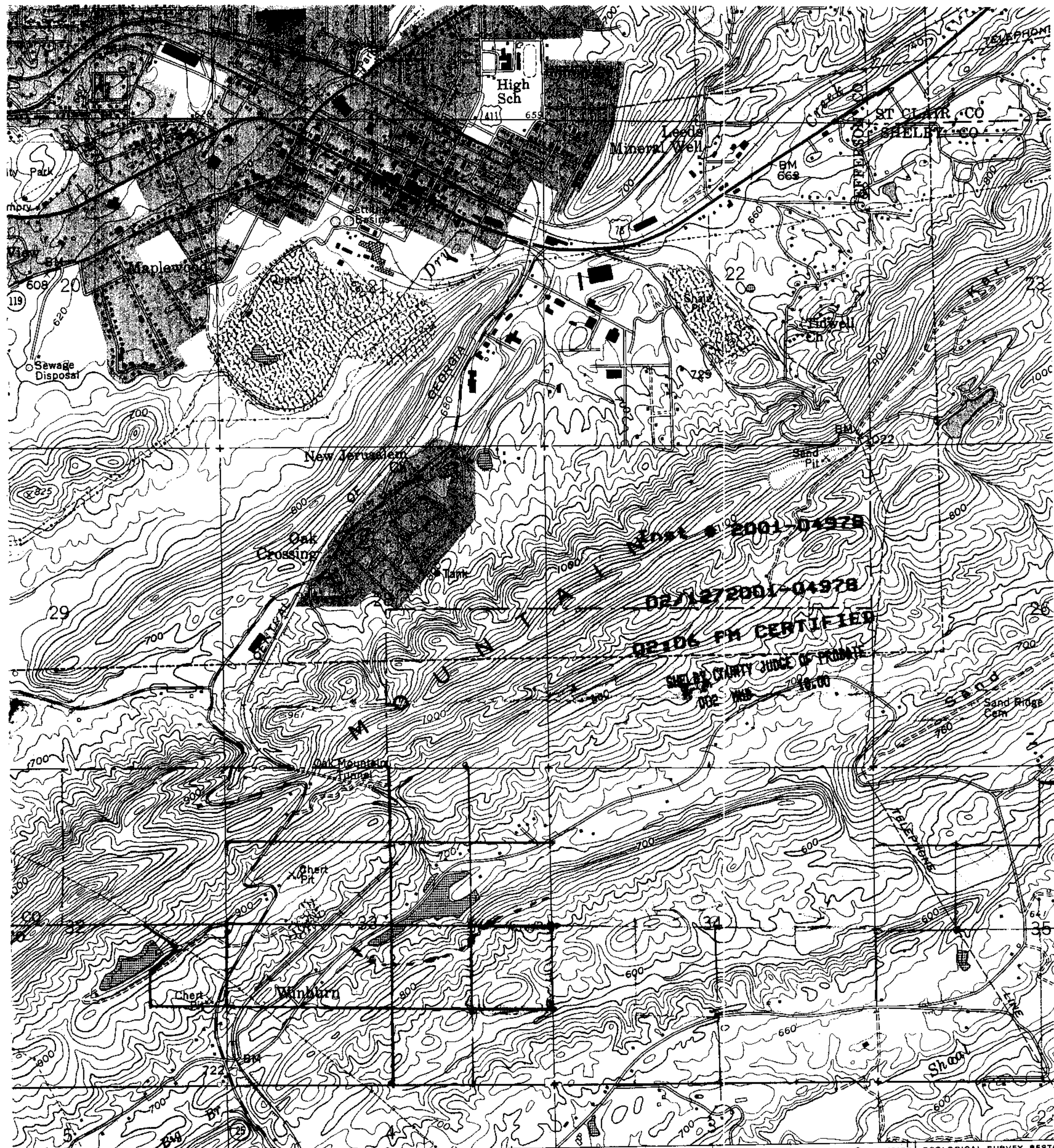
