WARRANTY DEED, JOINT FOR LIFE WITH REMAINDER TO SURVIVOR

That in consideration of One Dollar and other good and valuable consideration to the undersigned grantor, or grantors in hand paid by the grantees herein, the receipt whereof is acknowledged, the said, 3-M Developers, LLC, an Alabama Limited Liability Company (herein referred to as grantor) does, grant, bargain, sell and convey unto Jerry G. Thompson and Sherry R. Thompson (herein referred to as grantees) for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 100 A, according to the Final Plat of Lot 100 A of Ivy Brook, Phase Two, Third Addition as recorded in Map Book 27, Page 96 in the Probate Court of Shelby County, Alabama.

Subject to restrictions, easements, and rights of way of record.

Subject to advalorem taxes for the years 2001, and years subsequent to that date.

TO HAVE AND TO HOLD, to the said Grantees for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, and to their heirs and assigns, forever. It being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

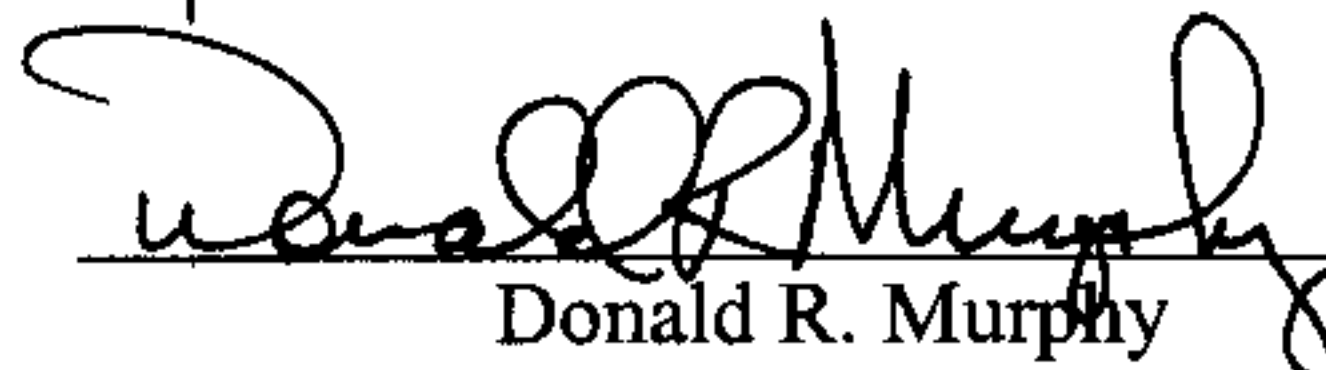
