A parcel of land situated in the SE 1/4 of the SW 1/4 of Section 35, Township 19 South, Range 1 West, and the NE 1/4 of the NW 1/4 of Section 2, Township 20 South, Range 1 West, Shelby County, Alabama, being more particularly described as follows:

Commence at the SW corner of the SE 1/4-SW 1/4 of said Section 35; thence South 89 degrees, 56 minutes, 25 seconds East, along the South line of said 1/4-1/4 section, a distance of 439.43 feet; thence South 1 degrees, 32 minutes, 57 seconds West and leaving said South line a distance of 254.12 feet to a point in the centerline of an asphalt Shelby County Road known as Whisenhunt Road and also being a point of the beginning of a curve to the right having a radius of 400.00 feet, a central angle of 6 degrees 51 minutes 29 seconds and subtended by a chord which bears North 79 degrees 30 minutes 49 seconds East, a chord distance of 47.85 feet; thence along the arc of said curve, and along said centerline a distance of 47.88 feet to the end of said curve; thence North 81 degrees 09 minutes 17 seconds East along said centerline a distance of 125.11 feet to the beginning of a curve to the right having a radius of 400.00 feet, a central angle of 5 degrees 38 minutes 43 seconds and subtended by a chord which bears North 81 degrees 46 minutes 54 seconds East, a chord distance of 39.40 feet; thence along the arc of said curve and along said centerline, a distance of 39.41 feet to a point, said point being the Point of Beginning and the beginning of a curve to the left having a radius of 205.00 feet, a central angle of 30 degrees 35 minutes 53 seconds and subtended by a chord which bears North 5 degrees 54 minutes 38 seconds West, a chord distance of 108.18 feet; thence along the arc of said curve and leaving said Whisenhunt Road a distance of 109.48 feet to the end of said curve; thence North 18 degrees 34 minutes 37 seconds West a distance of 77.35 feet; thence North 89 degrees 59 seconds 58 seconds West a distance of 107.01 feet; thence North 0 degrees 38 minutes 59 seconds East a distance of 291.11 feet; thence South 89 degrees 59 minutes 58 seconds East a distance of 192.45 feet to a point, said point lying on a curve to the left having a radius of 410.00 feet, a central angle of 16 degrees 16 minutes 50 seconds and subtended by a chord which bears South 18 degrees 25 minutes 35 seconds West, a chord distance of 116.11 feet; thence along the arc of said curve a distance of 116.50 feet to the end of said curve; thence South 10 degrees 57 minutes 39 seconds West a distance of 116.99 feet to the beginning of a curve to the left having a radius of 110.00 feet, a central angle of 29 degrees 32 minutes 16 seconds, and subtended by a chord which bears South 3 degrees 48 minutes 29 seconds East, a chord distance of 56.08 feet; thence along the arc of said curve a distance of 56.71 feet to the end of said curve; thence South 18 degrees 34 minutes 37 seconds East a distance of 75.49 feet to the beginning of a curve to the right having a radius of 240.00 feet, a central angle of 28 degrees 35 minutes 37 seconds and subtended by a chord which bears South 6 degrees 42 minutes 48 seconds East, a chord distance of 118.53 feet; thence along the arc of said curve a distance of 119.77 feet to its intersection with aforesaid centerline of Whisenhunt Road, which is also a point on a curve to the left having a radius 400.00 feet, a central angle of 5 degrees 06 minutes 50 seconds, and subtended by a chord which bears South 87 degrees 09 minutes 41 seconds West, a chord distance of 35.69 feet; thence along the arc of said curve and along said centerline of Whisenhunt Road a distance of 35.70 feet to the Point of Beginning.
