KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of Five Hundred and No/100 Dollars (\$500.00) and other good and valuable consideration to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged **LARRY RESTINE & WIFE, ANN GIAMBRONE**, now know as **ANN T. RESTINE**, (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **LARRY RESTINE & ANN T. RESTINE**, (herein referred to as "Grantee"), as joint tenants with rights of survivorship, their interest in the following described real estate situated in Shelby County, Alabama, to w t:

Lot 39, according to the 1st Amended Plat of Greystone Farms, Milners Crescent Sector, Phase 1, as recorded in Map Book 19, Page 140, in the Probate Office of Shelby County, Alabama.

Subject to all easements, restrictions, covenants, rights of way of record; taxes for 2001 and subsequent years not yet due and payable.


The purpose of this Deed is to convert title into the married name of Ann T. Restine.

AND THE GRANTOR does for their heirs and executors, successors and assigns, covenant with said Grantee, their heirs, executors, successors and assigns, that Grantor is lawfully seized in fee simple of the premises, that they are free from all encumbrances, unless otherwise noted above, that Grantor has good right to sell and convey the same as aforesaid, and that Grantor will and their heirs and executors, successors and assigns shall warrant and defend same to said Grantee, their heirs, executors, successors and assigns forever, against the lawful claims of all persons.


