Commence at the Southeast corner of said Section 34; thence run along the South line of said Section in a Westerly direction a distance of 2,202.08 feet to a point on the Easterly right of way of County Road No. 41, otherwise known as Dunavant Valley Road; thence turn a deflection angle of 105° 33' 12" to the right and run in a Northeasterly direction along said Easterly right of way a distance of 686.39 feet to a found crimped iron, said point being the point of beginning of the parcel herein described; thence continue on the last described course in a Northeasterly direction along said Easterly right of way a distance of 683.44 feet to a found crimped iron; thence turn an interior angle of 105° 23' 56" and run to the right in an Easterly direction a distance of 531-84 feet to a found crimped iron; thence turn an interior angle of 180° 32' 52" and run to the left in an Easterly direction a distance of 656.11 feet to a found 3 inch capped pipe; thence turn an interior angle of 179° 56' 00" and run to the right in an Easterly direction a distance of 637.50 feet to a point on the East line of said Section 34; thence turn an interior angle of 90° 04' 55" and run to the right in a Southerly direction along said East section line a distance of 725.24 feet to an iron rod; thence turn an interior angle of 87° 52' 57" and run to the right in a Westerly direction a distance of 2,014.68 feet to the point of beginning.
