Know All Men by These Presents: That in consideration of **Eighty seven thousand nine hundred and no/100 (\$87,900.00)** to the undersigned grantor **Abana Enterprises**, a corporation, in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Abana Enterprises** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Mathew Mason and Sherri Mason** (herein referred to as grantee, as joint tenants of survivorship whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

Subject to existing easements, restrictions, set-back lines, right of way, limitations, if any of record.


\$87,730.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.
