This Subordination of Mortgage is executed this 6th day of February, 2001 by
SouthTrust Mortgage Corporation.

WITNESSETH

WHEREAS, SouthTrust Mortgage Corporation is the owner and holder of that certain mortgage from N. Dewayne Pope and his wife Andrea P. Pope recorded in Instrument 2000/23764 in the Probate Office of Shelby, Alabama, said property being more particularly described as follows:

NOW, THEREFORE, for and in consideration of the premises hereof and of mutual advantages and benefits accruing to the parties hereto and in further consideration of the sum of Ten and 00/100 Dollars (\$10.00) in hand paid by SouthTrust Mortgage Corporation to SouthTrust Mortgage Corporation, the receipt and sufficiency of which is hereby acknowledged, SouthTrust Mortgage Corporation does hereby covenant, consent and agree to and with SouthTrust Mortgage Corporation that the lien of SouthTrust Mortgage Corporation shall be and the same is hereby made subordinate, inferior and subject in every respect to the lien of SouthTrust Mortgage Corporation which encumbers the above described property provided, however, that the subordination is limited to the amount of Forty-six Thousand Four Hundred and 00/100 Dollars (\$46,400.00).
