Subject to existing easements, restrictions, set back lines, right of ways, limitations, if any, of record.

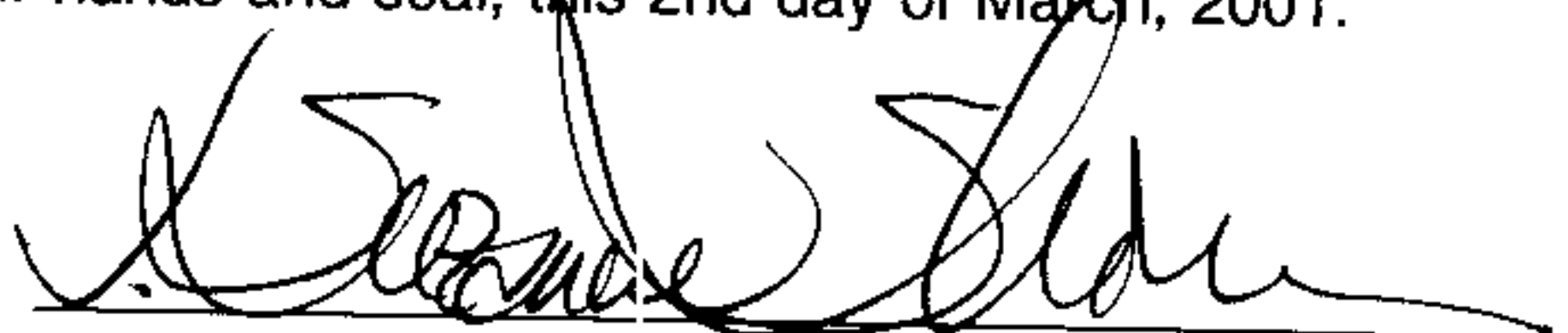
Subject to that certain mortgage dated March 2, 2001.

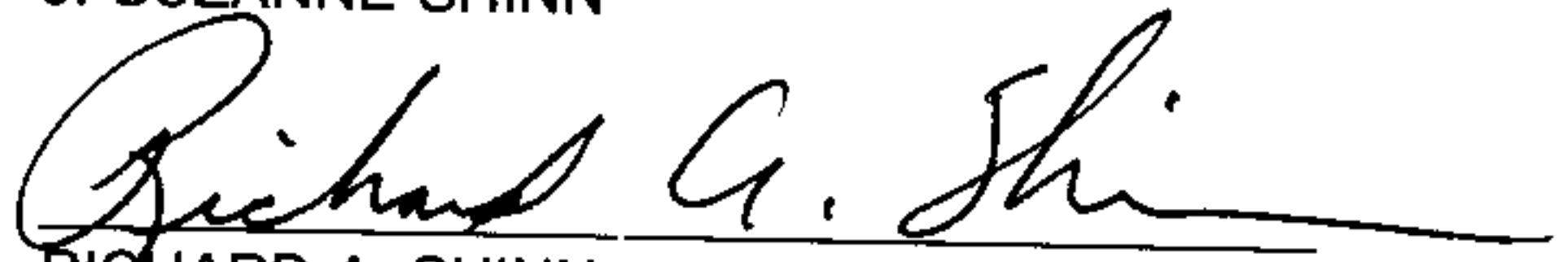
Subject to that certain second mortgage dated March 2, 2001.

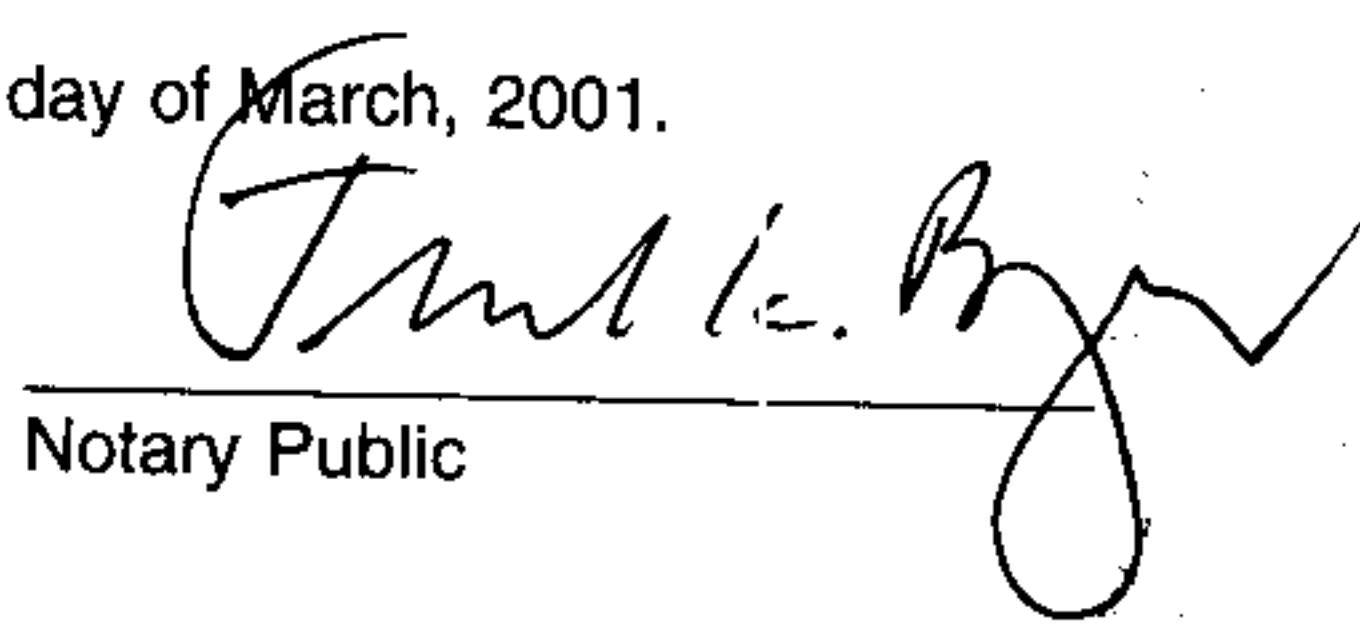
