In fact, the property was sold to my husband J. Allen Chesser by his parents Frank Pearon Chesser and Dovie Chesser before our marriage in June 11, 1955.

In 1940, Frank P. And Dovie Chesser built the home on the property; in years following wedave updated and added to the original 1940 home structure. In 1976, the home was first remodeled by local contractor, Glen Autry, Sr.; the following year, a well was drilled nearby the home for garden and outside usage. Then in 1997, a major remodeling was done including a room addition; then, in 1980, an inground pool was constructed.

The total property as shown by Conn & Allen survey dated June 28,2000 has been used totally and continuously lived upon, used by and maintained by the J. Allen and Betty S. Chesser Family as well as parents Frank P. And Dovie Chesser. (Conn & Allen, Licensed Alabama Land Surveyor # 12944, 2850 E. Pelham Mall, Pelham, Alabama 35124)

The fence was put in place by J. Allen Chesser and son Allen A. (Billy) Chesser in 1967; the fence was constructed along the entire southern property boundary, the Shelby County 47 side, and midway running in a northern direction of the present Reese property boundary line. In fact, in 1967, Mr. Charlie Holcombe had a boundary survey of his property and it was with Mr. Charlie Holcombe's blessing and supervision that subject fence was put in place on Chesser/Holcombe property lines.

Additionally, 1961, the J. Allen and Betty Chesser family built a 510 foot chicken house and egg house on the property; in 1968, a Butler-type building was constructed on the property.

Three children were born to the family of J. Allen and Betty S. Chesser. Son Johnny has remained continuously on the property. After his marriage he moved into the little yellow house located on subject property; in 1984 the little home was remodeled. Presently, plans are underway to destroy the little yellow house and the old egg house.
