KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of **One Hundred Nine Thousand and 00/100 Dollars (\$109,000.00)** to the undersigned GRANTORS in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, **David H. Wilkins and Sharon G. Wilkins, husband and wife** (hereinafter referred to as GRANTORS), do hereby grant, bargain, sell and convey unto **Tim Oakley and JoLynn Faith Oakley, husband and wife** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in the County of **Shelby** and State of Alabama, to-wit:

**\$103,550.00 of the above purchase price is in the form of a mortgage in favor of Castle Mortgage Corporation, executed and recorded simultaneously herewith.**



**This conveyance is hereby made subject to restrictions, easements and rights of way of record in the Probate Office of Shelby County, Alabama.**
