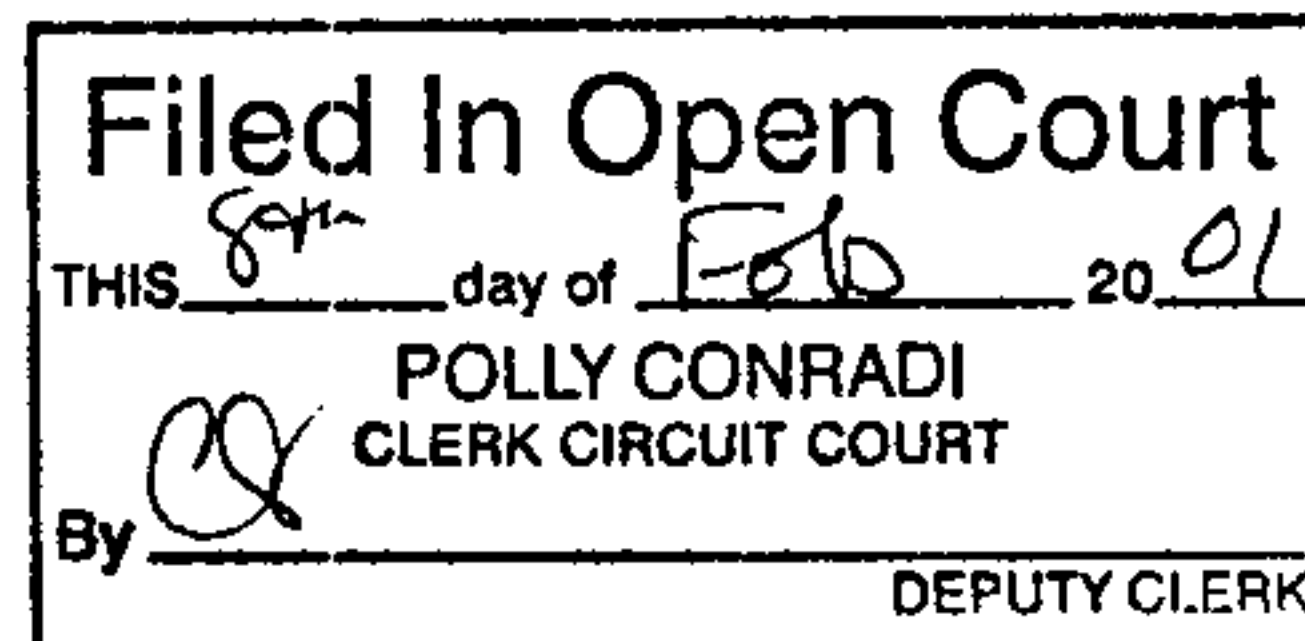

CONSENT JUDGMENT

WHEREAS, on or about June 16, 1998, Rives Construction Company sued Jack M. Hollingsworth d/b/a Hollingsworth and Associates ("Hollingsworth"), Rives & Peterson, a professional corporation ("Rives & Peterson") and other defendants seeking recovery of certain monies due and owing for tenant improvements in The Financial Center, and,

WHEREAS, Jack M. Hollingsworth individually and d/b/a Hollingsworth and Associates was a subtenant of Rives & Peterson at The Financial Center, and,

WHEREAS, Rives & Peterson instituted a crossclaim against Hollingsworth to recover monies due for rents and charges under its sublease agreement and otherwise, and,

WHEREAS, over time, Hollingsworth did pay to Rives Construction Company sums sufficient to discharge his liability to Rives Construction Company but Hollingsworth did not satisfy his past and ongoing obligations to Rives & Peterson for which recovery was claimed through Rives & Peterson's crossclaim, and,

WHEREAS, on or about the 30th day of July, 1999, Rives Construction Company filed a dismissal of its claims against Hollingsworth with prejudice, and,

WHEREAS, Rives & Peterson did not release or satisfy any of the claims it has against Hollingsworth, and,

WHEREAS, on or about September 24, 1999, this Honorable Court granted Rives & Peterson's motion to realign the parties and directed the clerk to reflect Rives & Peterson as the plaintiff and Jack M. Hollingsworth as the defendant, and,

WHEREAS, the remaining parties, Rives & Peterson, and Hollingsworth, have reported to the Court that they have entered into an agreement to resolve this litigation in the form of a Consent Judgment,

NOW, THEREFORE, it is hereby ORDERED, ADJUDGED and DECREED as follows:

1. Judgment is hereby rendered in favor of Rives & Peterson, a professional corporation, and against Jack M. Hollingsworth individually and Jack M. Hollingsworth d/b/a Hollingsworth & Associates in the amount of \$35,851.56 for past due rent and other charges, plus \$4,000.00 additional attorney fees for a total judgment of \$39,851.56. Costs incurred herein are taxed to the defendant.

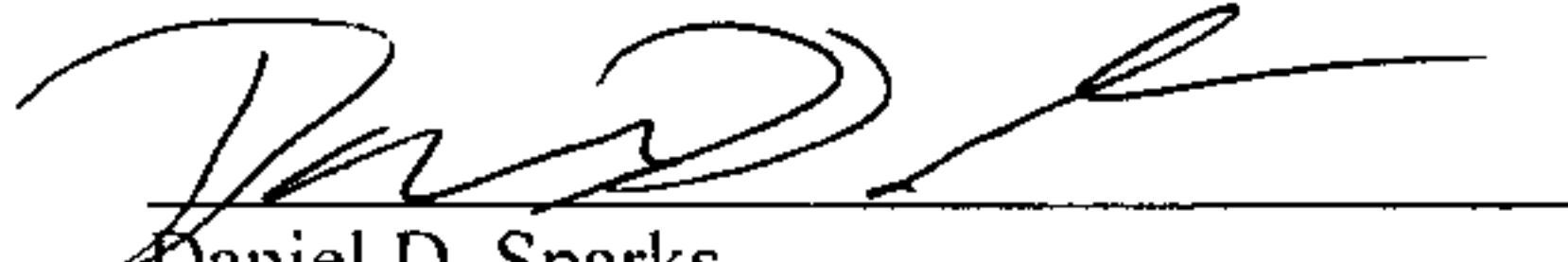
