THAT IN CONSIDERATION OF Ten Dollars and other good and valuable consideration paid to the undersigned Grantor, in hand paid by the Grantee herein, the receipt of which is hereby acknowledged, **FOREST PARKS, LLC**, an Alabama limited liability company (herein referred to as Grantor), does grant, bargain, sell and convey unto **THE HIGHWAY 43 FOREST PARKS RESIDENTIAL ASSOCIATION, INC.**, an Alabama non-profit corporation (herein referred to as Grantee), the following described real estate, situated in the State of Alabama, County of Shelby, to-wit:

An easement for signage and landscaping located along Lots 201 and 240, according to the survey of Forest Parks, Second Sector, as recorded in Map Book 22, at Page 71 in the Office of the Judge of Probate of Shelby County, Alabama and also an easement for signage and landscaping located along Lots 903 and 904, according to the survey of Forest Parks, 9<sup>th</sup> Sector, as recorded in Map Book 24, at Page 138A & B in the Office of the Judge of Probate of Shelby County, Alabama together with Grantor's rights in and to all signage, landscaping, and plantings located along said easement and also all signage, landscaping, and plantings located along and adjacent to the two entrances to Forest Parks from Shelby County Road 43.
