KNOW ALL MEN BY THESE PRESENTS,

That in consideration of TWO HUNDRED FORTY TWO THOUSAND FIVE HUNDRED AND NO/100 DOLLARS (\$242,500.00), to the undersigned grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **MCGINNIS CONSTRUCTION CO., INC.**, a corporation, (herein referred to as Grantors) do grant, bargain, sell and convey unto **KEITH ROLLINS BROWN AND JANET FARLEY STEPHENS** (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:
