KNOW ALL MEN BY THESE PRESENTS: That for and in consideration of the sum of One Dollar(\$1.00) cash in hand paid by Shelby County, the receipt of which is hereby acknowledged, we, the undersigned, do hereby grant, bargain, sell and convey unto said Shelby County, its successors and assigns, an easement for sanitary sewer purposes, said easement being 30 feet in width as now or thereafter located over, across or through the property of the undersigned which is described as follows:

## Easement #4 (U. S. Postal Service)

A utility easement situated in Lot 1 of Meadowbrook Post Office as recorded in Map Book 11 on Page 73 in the Office of the Judge of Probate, Shelby County, Alabama being more particularly described as follows:

Commence at a concrete monument found locally accepted to be the Northeast corner of Section 6, Township 19 South, Range 1 West; thence run in a Southerly direction along the East line of said Section 6 and also along the East line of said Lot 1 for a distance of 200.39 feet to the point of beginning; thence continue along last stated course for a distance of 77 65 feet to a point on the Northwest right-of-way line of Cahaba Valley Road, State Highway #119; thence turn an angle to the right of 22 degrees, 43 minutes, 43 seconds and run in a Southwesterly direction along said Northwest right-of-way line for a distance of 400.00 feet to the intersection of said Northwest right of 90 degrees, 00 minutes, 00 seconds and run in a Northwesterly direction along said Northeast right-of-way line for a distance of 30.00 feet to a point; thence turn an angle to the right of 90 degrees, 00 minutes, 00 seconds and run in a Northeasterly direction 30 feet from and parallel to said Northwest right-of-way line for a distance of 471.62 feet to the point of beginning.
