THIS FORECLOSURE DEED made this 3<sup>rd</sup> day of April, 2001 between SHERRY HOWELL, an unmarried woman, Party of the First Part, and BANK ONE, NATIONAL ASSOCIATION, AS TRUSTEE, Party of the Second Part;

W I T N E S S E T H:
