WITNESSETH:

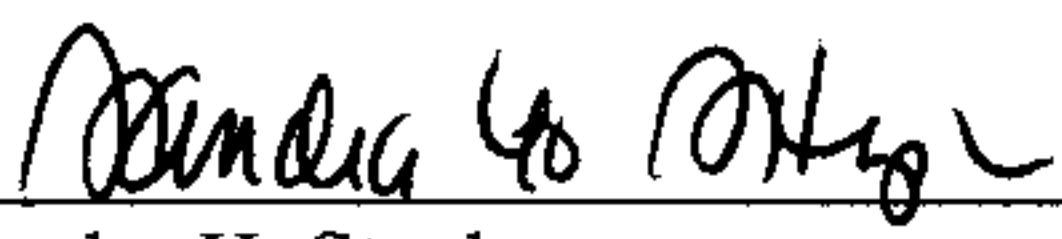
