CERTIFICATE OF INCORPORATION

The undersigned Directors of THE GIFTS OF MY FATHER, INCORPORATED, pursuant to the Laws of the State of Alabama as set forth by Section 10-3A-1, et seq. of the 1975 Code of Alabama, as amended, with the intent of qualifying as a Non-Profit Corporation under Section 501 (c)(3) of the Internal Revenue Code or any successor of same, do by these presents adopt this Certificate of Incorporation.

ARTICLE I

NAME & PERIOD OF DURATION

The name of the Corporation shall be **THE GIFTS OF MY FATHER, INCORPORATED**, and it shall be located in the City of Birmingham, Shelby County, Alabama. The period of duration for the Corporation is perpetual.

ARTICLE II

PURPOSES AND POWERS

- (A) This Corporation shall have the authority/purpose to advance the Christian faith and particularly the teachings and practices of Jesus Christ as set forth in the HOLY BIBLE.
- (B) This Corporation shall have all the general powers granted to Corporations by Section 10-3A-20 et seq., Code of Alabama 1975.
- (C) No part of the income of this Corporation shall inure to the benefit of or be distributed to its Director or any private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for service rendered and distribution in furtherance of the Corporation's purposes as set forth herein.
- (D) This Corporation shall have power and authority to guarantee or become surety for the obligations of any other non-profit corporation or corporation not of a business character.



(E) The nature of the said corporation is religious and as a religious corporation it shall also have the authority to function as a religious, charitable, benevolent, and educational corporation, for all members of the society of humanity, individually, and collectively, worldwide.

ARTICLE III

MEMBERSHIP

The membership of the corporation shall be all of one class and the membership shall consist of those persons who profess their faith in Jesus Christ as their Savior and Lord, giving satisfactory proof of conversion to the Christian faith, as is set forth in the New Testament, who have petitioned the Board of Directors of the corporation for membership and have been accepted according to the terms of the Constitution and By-Laws of this Corporation. All procedures for admission, dismissal, and transfer shall be as provided by the Constitution and By-Laws of said The Gifts of My Father, Inc.

ARTICLE IV

DIRECTORS

There shall be five Directors which shall serve a term of three years, but always eligible for re-election. The original Directors shall serve for terms as hereinafter stated under this Article. Thereafter the Directors shall serve for a full term of three years. The Directors shall meet at least annually. The name of the original Directors of the Corporation and the length of the initial term for which he/she shall serve is as follows:

The length of time for which such Directors are elected shall be until their successor are duly elected and qualified.

Thereafter the term for which the Directors shall be elected and serve shall be three (3) years, or such portion thereof as may be required to fill the unexpired term for which the predecessor of such Director was elected and until his/her respective successor shall be elected and qualified.

ARTICLE V

DUTIES AND RESPONSIBILITIES OF DIRECTOR

The Director of the Corporation shall have the following duties and responsibilities, viz: The buying, selling and mortgaging of all real and personal property for the Corporation; the acquiring and conveying of title to the said property; the holding and defending of title to the said property; and the managing of any permanent special funds or assets entrusted to the Corporation of its Director, whether by gift, devise, bequest, contribution or otherwise, for the furtherance of the purposes of the Corporation, and all such other assets which may belong to the Corporation, which require handling or negotiation by a corporate entity, but not such funds as are otherwise collected for the support and expense of the Corporation, an for the benevolent purposes of the Corporation, which shall be controlled and disbursed by the Corporation officers; and provided that in buying, selling and mortgaging real property, such Director shall act solely under authority of the Corporation granted in a duly constituted meeting of the Corporation required by the Laws of the State of Alabama.

ARTICLE VI

BY LAWS

The affairs of this Corporation and the regulation and conduct thereof shall be contained in the By-Laws, which By-Laws may be prescribed, made, altered or repeated from time to time upon a majority vote of those members present and voting when the Corporation is sitting in duly called and held business meeting. The By-Laws may be amended, altered or rescinded by the Corporation sitting in regular business meeting as provided and allowed by the Corporation By-Laws.

ARTICLE VII

BUSINESS MEETING

The business meeting may be held on any regularly scheduled meeting of the membership of any specifically scheduled and publicized business meeting of the members of the Corporation. The By-Laws of same shall provide for regularly scheduled meetings, publication for the transactions of business and for the calling of special meetings called for the transaction of special business. The quorum required for the transaction of business shall be as provided in the By-Laws of Corporation.

ARTICLE VIII

TITLE TO REAL ESTATE

The title of all property shall be vested in the name of said Corporation.

ARTICLE IX

LOCATION OF CORPORATION OFFICE

The address of the Corporation and the location of it's principal office in the State of Alabama is 5125 Shadowbrook Trail, Birmingham, AL 35244.

ARTICLE X

NAME AND ADDRESS OF INITIAL AGENT

& INCORPORATOR OF CORPORATION

The name of the Initial Agent and Incorporator of the Corporation is Donna Sandlin.

ARTICLE XI

AMENDMENTS

The Corporation may amend, alter or repeal any provisions of this Certificate of Incorporation as may be desired by a two-thirds (2/3) vote of those present and voting when the Corporation is sitting in duly called and held business meeting as provided by its By-Laws.

ARTICLE XII

TRANSFER OF ASSETS IN THE EVENT OF DISSOLUTION

If this Corporation should ever be dissolved, all of its assets remaining after payment and satisfaction of all its costs, and indebtedness, including the expenses of such dissolution shall be distributed to non-profit corporations, or other organization, which is qualified for exemption under Section 501(c)(3) of the Internal Revenue Code or any successor to said Section.

The members of said Corporation defined in Article III who are members in good standing at the time of dissolution of said Corporation shall in a duly called business meeting, designate the non-profit corporation(s) or organization(s) to receive assets of the Corporation upon dissolution. No assets of any substantial value of said Corporation shall be distributed to any member or officer or Director of this Corporation.
