

DURABLE POWER OF ATTORNEY

I, Edith S. Hanners the undersigned, do hereby nominate and appoint Joseph M. Hanners my true and lawful attorney in fact for me and in my name, place and stead and on my behalf and for my use and benefit:

1. To exercise or perform any act, power, duty, right or obligation whatsoever that I now have, or may hereafter acquire the legal right, power or capacity to exercise or perform in connection with, arising from or relating to any person, item, transaction, thing, business, property both real and personal, tangible or intangible, or any other matter whatsoever. My attorney shall have the power to sign deeds, convey property and do all other things in my name whether enumerated herein or not.

2. This power of attorney shall include authority for my attorney in fact to perform the following acts in my name, place and stead:

- To Sell or transfer stock or other securities, whether certificates which evidence the shares of such stock or other securities are held by myself, a brokerage house or other financial institution or by any other person, firm, or corporation;
- To sell or transfer any real property which I own, including but not limited to the following properties:

general Power of Attorney and a Durable Power of Attorney. My attorney in fact is empowered to do all things on my behalf and same as I could do if I were present.

4. This Durable Power of Attorney shall not be affected by any disability, incapacity or incompetence on my part, except as provided by the Statutes of the State of Alabama. The power conferred on my attorney-in-fact by this instrument shall be exercisable from the date hereof notwithstanding a later disability, incapacity or incompetence on my part.

5. All acts done by my attorney-in-fact pursuant to the power conferred by this durable power of attorney during any period of my disability, incapacity or incompetence shall have the same effect and inure to the benefit of and to bind me or my heirs, devisees and personal representatives as if I were competent and not disabled.

6. This durable power of attorney shall be non-delegable and shall be valid until such time as I die or revoke this power.
