The Carlisle Corporation files this statement in writing, verified by the oath of Dennis W. Carlisle, Sr., President, who has personal knowledge of the facts herein set forth: That The Carlisle Corporation claims a lien upon the following property, situated in Shelby County, Alabama, to wit:

A parcel of land situated in the NW 1/4 of the SW 1/4 of Section 32, Township 18, Range 1 West, Shelby County, Alabama, more particularly described as follows:
Commence at the Northwest corner of said 1/4 - 1/4; thence Southerly along the West Line of said 1/4 - 1/4 a distance of three hundred twenty-seven and 86/100 (327.86) feet to a point; thence turn sixty-four (64) degrees, forty-two (42) minutes, seventeen (17) seconds left and run Southeasterly a distance of two hundred forty and 53/100 feet (240.53) to the point of beginning of property herein described; thence continue Southeasterly along last stated course a distance of seven hundred eleven and 18/100 (711.18) feet to a point of the Westerly right of way line on Alabama Highway # 119; thence turn ninety-four (94) degrees, twelve (12) minutes, thirty (30) seconds left and run Northeasterly and along said Westerly right of way line a distance of one hundred twenty (120) feet; thence turn eighty-five (85) degrees forty-seven (47) minutes and thirty (30) seconds left and run Northwesterly a distance of seven hundred ten and 25/100 (710.25) feet; thence turn ninety-three (93) degrees forty-six (46) minutes left and run Southwesterly a distance of one hundred nineteen and 94/100 (119.94) feet to the Point of Beginning.

This lien is claimed, separately and severally, as to both the buildings and improvements thereon, and the said land. That said lien is claimed to secure an indebtedness of forty-nine thousand eight hundred two dollars (\$49,802.00), together with interest and attorney's fees, for labor and materials provided in the construction and/or improvement of and on said premises.
