AGREEMENT FOR SUBORDINATION OF MORTGAGE

- 2. <u>Effect of Subordination</u>. The subordination of the Existing Mortgagee to The Bank shall have the same force and effect as though The Bank have been executed, delivered, and recorded in the Recording Office prior to the execution, delivery and recordation of the Existing Mortgage.
- 3. <u>Parties Bound</u>. This Agreement shall be binding on and inure to the benefit of the respective heirs, successors and assigns of the parties.
