WHEREAS, **MULTI-VEST, INC.** is the owner of all the property abutting on or adjacent to the following described property and the public easement over and across said property that is proposed to be vacated, situated in Shelby County, Alabama:

Commence at the Southwest corner of Lot 230 of Bent River Commons 2nd Sector as recorded in Map Book 25, page 25 in the Probate Office of Shelby County, Alabama; thence run North 83° 23' 21" East along the South line of said Lot 230 for a distance of 32.73 feet to the point of beginning; said point being the centerline of a 15 foot easement lying 7.5 feet to either side of the following described line; thence run North 14° 52' 12" East a distance of 116.73 feet to the point of ending.

Situated in Shelby County, Alabama.

WHEREAS, the above owner is desirous of vacating said tract of land described above and the public easement over and across said property and requests that the assent of the County Commission of Shelby County, Alabama be given as required by law in such cases;

That after vacation of the above described tract of land and the public easement over and across said property, and all public rights and easements therein, convenient means of ingress and egress to and from the property will be afforded to all other property owners owning property in or near the tract of land embraced in said map, plat or survey by the remaining streets, avenues, or highways dedicated by said map, plat, or survey.
