Know All Men by These Presents: That in consideration of **One hundred thirty two thousand nine hundred and no/100 (\$132,900.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Thomas J. Fisher and Suzette Y. Fisher, husband and wife** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Richard E. Mullen, III and Barbara Neale Mullen** (herein referred to as grantee, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

\$85,000.00 of the purchase price recited above was paid from mortgage loan closed simultaneously herewith.

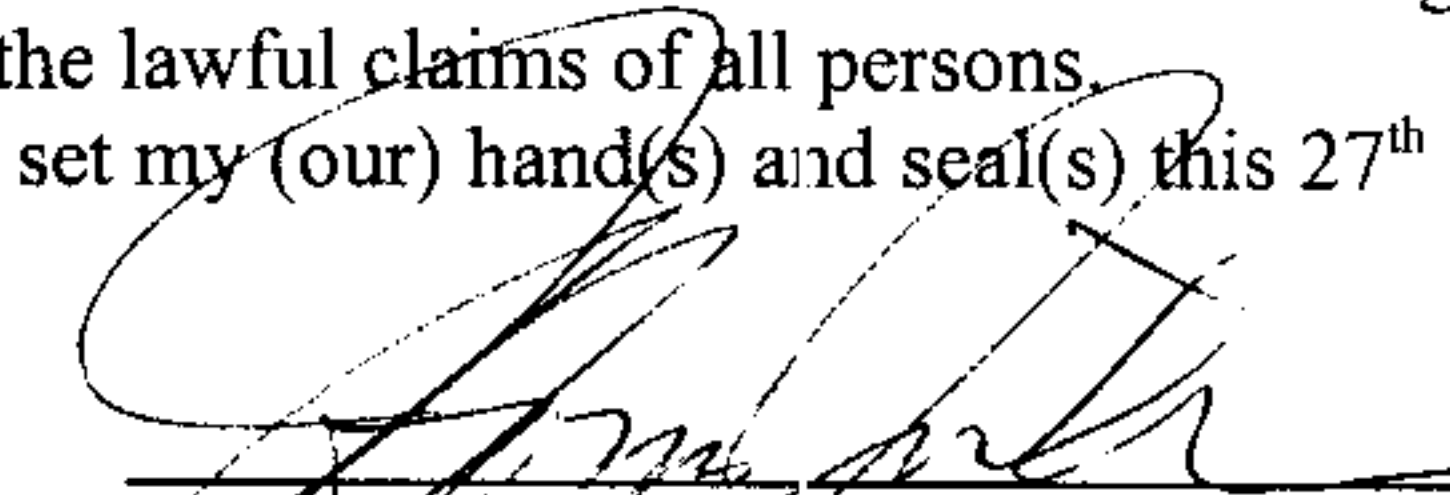
