Dear Mr. Crim:

We are writing to you to confirm that you do NOT have permission of any kind, written or oral, express or implied, OR any agreement of any kind which allows you to be on OR exercise control over real property owned by us, either in joint or individual ownership, in Shelby County, Alabama, Sections 20 and 29, Township 21 South, Range 2 West.

You should CEASE AND DESIST from any activity which could possibly interfere with parties having a lease or permission from us using the property.

Of particular concern are our parcels of 21 acres (S $\frac{1}{2}$, SE $\frac{1}{4}$, NW $\frac{1}{4}$, 29, 21S, 2W) and 63 acres (N $\frac{1}{2}$, NW $\frac{1}{4}$, NW $\frac{1}{4}$ and NE $\frac{1}{4}$, NW $\frac{1}{4}$ SW of R/R ROW, 29, 21S, 2W). We are not in the city of Alabaster or Calera.

We would remind you that there are firearms regulations within city areas which are adjacent to our property, although our property is in the county.

There should be no clearing of fields, construction of structures of any nature or the like on our property.


