SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT, made and entered into this the day of April, 2001 by and between First Commercial Bank, (hereinafter "First Commercial"), and Regions Bank (hereinafter "Regions").

NOW THEREFORE, in consideration of the premises and the sum of Ten and 0° 100 (\$10.00), receipt of which is acknowledged, the undersigned do/does hereby agree that the mortgage lien of Brigham Williams, Inc. to First Commercial, dated April 30°, 2001, and recorded in Instrument No. 1996-09059 in the Office of the Judge of Probate of Shelby County, Alabama, shall be second and subservient to that certain first mortgage of A.D. Chandler Co., Inc. to Regions, dated 5114 of and recorded in Instrument No. 2001 - 21541, in the Office of the Judge of Probate of Shelby County, Alabama, to secure the sum of \$202,500.00, plus interest thereon, said lien of First Commercial Bank being subordinated to the first mortgage of Regions Bank.
