KNOW ALL MEN BY THESE PRESENTS,

That in consideration of TWO HUNDRED FIFTY FIVE THOUSAND AND NO/100 DOLLARS (\$255,000.00), to the undersigned Grantors in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **GERALD E. LOWE AND WIFE, MARLOU L. LOWE**, (herein referred to as Grantors) do grant, bargain, sell and convey unto **GREG D. MILLER AND MARTHA N. MILLER** (herein referred to as Grantees), as joint tenants, with right of survivorship, the following described real estate, situated in the State of Alabama, County of SHELBY, to-wit:
