WARRANTY DEED, JOINTLY FOR LIFE
WITH REMAINDER TO SURVIVOR

KNOW ALL MEN BY THESE PRESENTS, That in consideration of other good and valuable considerations and the sum of **One Hundred Eight Thousand and 00/100 Dollars (\$108,000.00)** to the undersigned GRANTORS in hand paid by the GRANTEES herein, the receipt of which is hereby acknowledged, **Patricia J. McDaniel and Edward C. Sherman, wife and husband** (hereinafter referred to as GRANTORS), do hereby grant, bargain, sell and convey unto **Sean C. Garrison and wife, Joyce F. Garrison, and Julia Caroline Fulmer and James E. Fulmer, husband and wife** (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate situated in the County of **Shelby** and State of Alabama, to-wit:

Lot 55, Block 2, according to the Amended Map of Bermuda Lake Estates, Second Sector, as recorded in Map Book 10 page 88 in Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.
