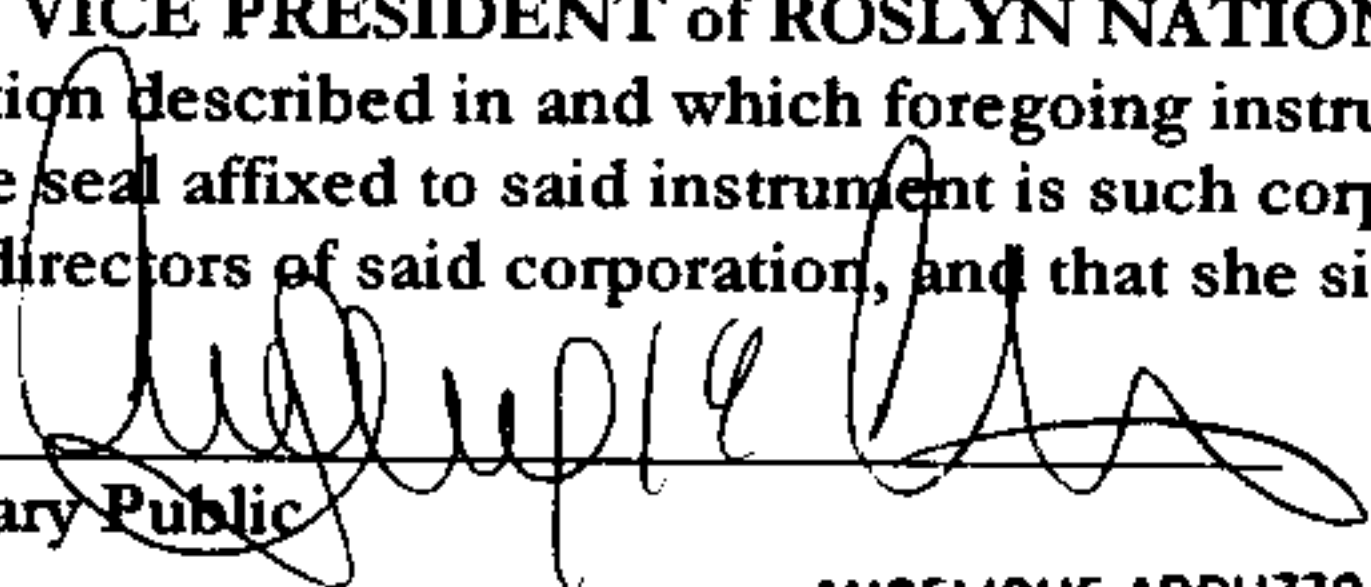

Parcel I:

Lot 237, according to the Survey of Savannah Pointe, Sector II, Phase I, as recorded in Map Book 25, Page 115, in the Probate Office of Shelby County, Alabama.

Parcel II:

An Ingress - Egress Easement for Lot 237 across Lot 236, both lots being recorded in Savannah Pointe, Sector 2, Phase I, in Map Book 25, Page 115, in the Judge of Probate Office of Shelby County, Alabama, situated in the North 1/2 of Section 31, Township 21 South, Range 2 West, Shelby County, Alabama, and being more particularly described as follows:

Begin at the Southwest corner of said Lot 237, said corner also being the Northeast corner of said Lot 236 and being on the Northwesternly right of way line of Hannah Circle, thence run Northwesternly along the common lot line of said Lot 236 and Lot 237 for 12.06 feet; thence turn 159 degrees 51 minutes 17 seconds left and run Southerly for 13.05 feet to a point on the right of way line of said Hannah Circle; said point being on a curve to the rights; thence turn 115 degrees 12 minutes 45 seconds left to become tangent to said curve, said curve subtending a central angle of 5 degrees 09 minutes 30 seconds and having a radius of 50.00 feet; thence run Northeasterly along the arc of said curve and along said right of way line for 4.50 feet to the point of beginning.
