KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of One Hundred Twenty-Five Thousand and No/100 Dollars (\$125,000.00) to the undersigned grantors, in hand paid by the grantee herein, the receipt of which is hereby acknowledged, **GARDNER BUILDERS, INC.** (herein referred to as "Grantor"), hereby grants, bargains, sells, and conveys unto **MICHAEL J. McDONALD and LAURIE SHERLENE McDONALD**, (herein referred to as "Grantee") as joint tenants with rights of survivorship, the following described real estate situated in SHELBY County, Alabama, to wit:

Subject to all easements, restrictions, covenants, rights of way and covenants of record; taxes for 2001 subsequent years not yet due and payable.

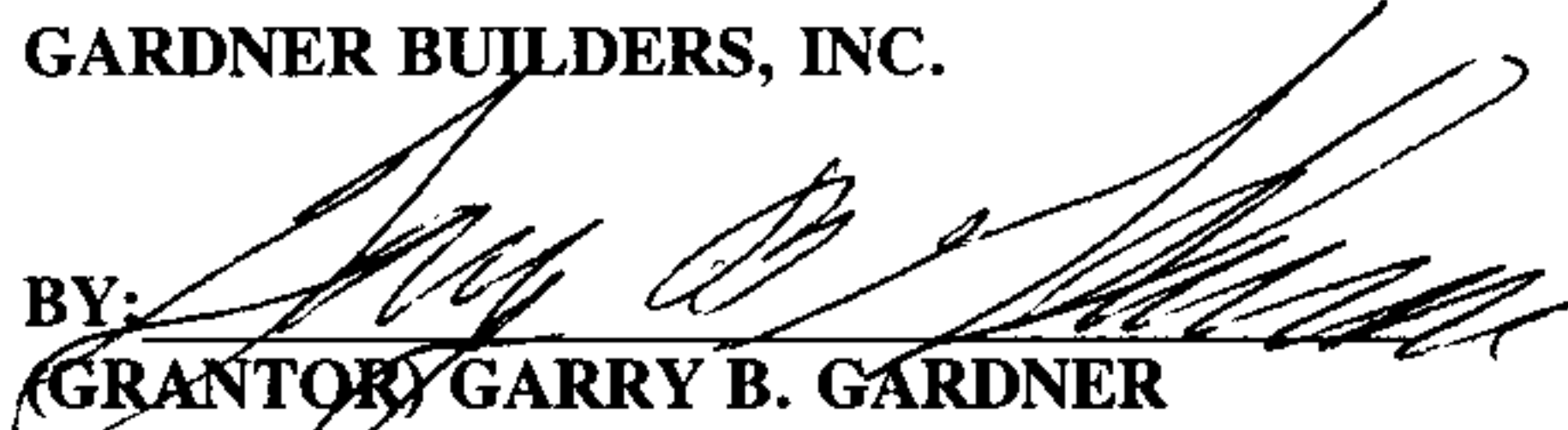
\$123,068.00 of the purchase price recited herein was paid from the proceeds of a mortgage loan closed simultaneously herewith.
