And as shown on the right of way map of Project No. STPAA-458(1) of record in the Alabama Department of Transportation, a copy of which is also deposited in the Office of the Judge of Probate of Shelby County, Alabama as an aid to persons and entities interested therein and as shown on the property plat attached hereto and made a part hereof:

A part of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, Section 14, Township 21 South, Range 3 West, identified as Tract No. 1, Project No. STPAA-458(1), Shelby County, Alabama, and being more fully described as follows:

Commence at the southeast corner of said SW $\frac{1}{4}$ of the NW $\frac{1}{4}$, thence west along the south line of said SW $\frac{1}{4}$ of NW $\frac{1}{4}$ a distance of 714 feet, more or less, to the present west right of way line of Alabama Highway 119; thence northerly along said right of way line a distance of 875 feet, more or less, to the south property line and the point of beginning of the property herein to be conveyed; thence continue northerly along said right of way line a distance of 154 feet, more or less, to the present south right of way line of a County Road, the north property line; thence west along said property line a distance of 54 feet, more or less, to a point that is 90 feet westerly of and at right angles to the centerline of said Project No. STPAA-458(1); thence southerly a distance of 150 feet, more or less, to a point on the south property line that is 90 feet westerly of and at right angles to said centerline; thence easterly along said property line a distance of 52 feet, more or less, to the point of beginning. 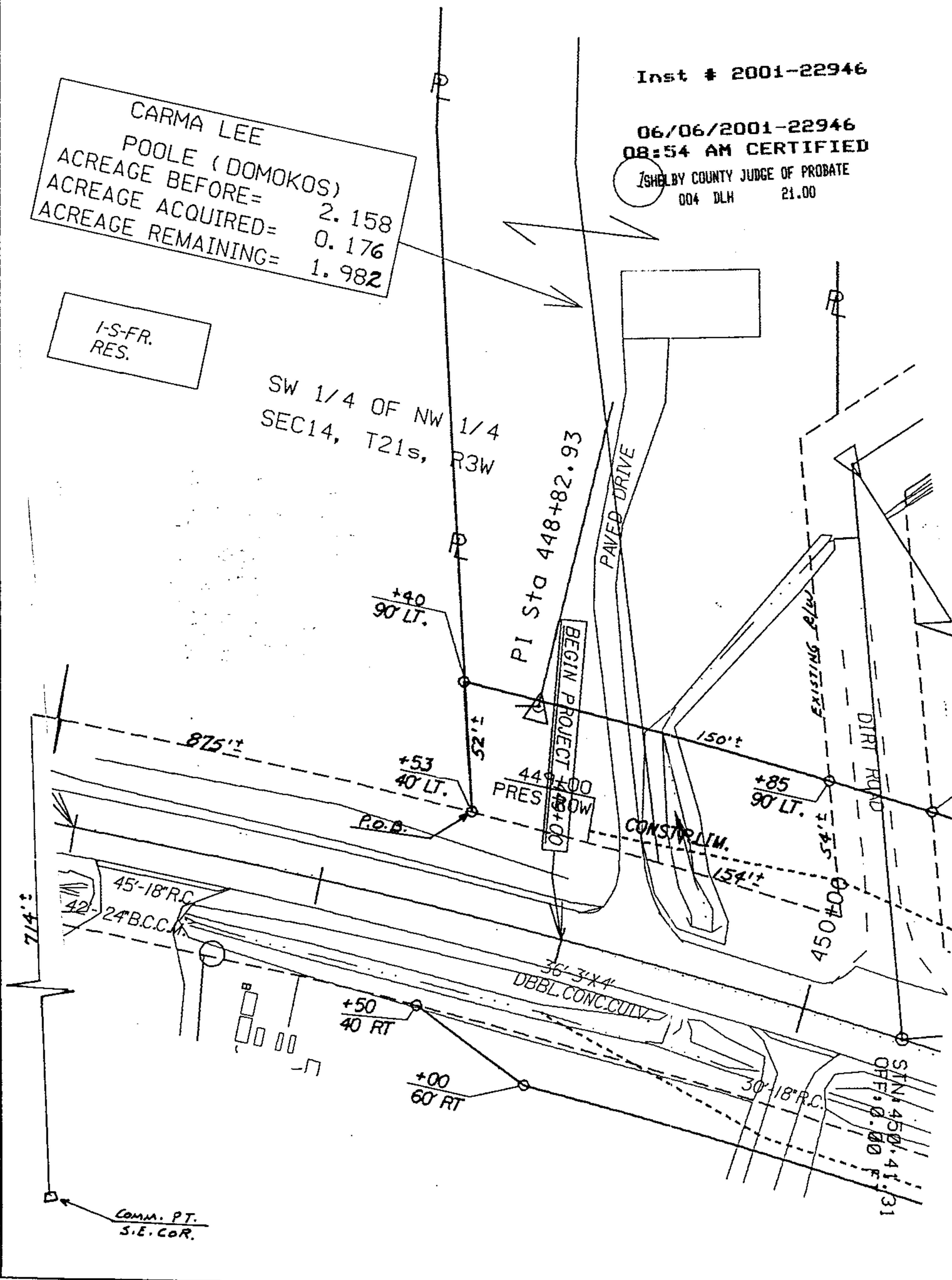
