- I, HAMPTON D. LEE do make and publish this my last will and testament hereby revoking all other wills heretofore made by me.
  - 1. I desire my just debts paid.
- 2. I give and devise to my wife, Exic R. Lee and to my brothers and sisters, Josie Ross, Lloyd Lee, Clarence Lee, and John Lee, and to Henry D. Lee, the son of my deceased brother, Richard Lee, and to Mathis Dickerson, the son of my deceased sister, Jessie Dickerson, the place known as the Hardin place in Perry County, Alabama, bought by me from The Federal Land Bank of New Orleans, and containing 240 acres, more or less, to be held and owned by them equally share and share alike.
- 3. I give and devise to my wife, Exic R. Lee, the Home Place in Marion, Alabama, near Lincoln School, now occupied by me as a residence, to be held, used and occupied by her and to receive the rents, incomes and profits therefrom, for and during the term of her natural life, and at her death to vest in fee simple in my brothers and sisters, or their descendants, the share of any deceased brother or sister, to vest in their children or their descendants, per stirpes.
- 4. To John H. Smith, of Montevallo, Alabama, I give, devise and bequeath the following property: The house and lot on Selma Street, in Montevallo, Alabama, now occupied by him as a residence. An undivided one-fourth (1/2) interest in the lot and buildings in Montevallo, Alabama now occupied by Montevallo Funeral Home; also a one-fourth interest in all personal property and equipment, good will and fixtures, now or at the time of my death, owned by said Montevallo Funeral Home and used by it in its business, including all accounts, contracts or unfinished business of every kind.
- 5. All the rest and residue of my estate of every king, real, personal and mixed which I may own or to which I may be entitled in any manner at the time of my death, I give, devise and bequeath to my wife, Exic R. Lee, to be held and owned by her absolutely and with out condition.

6. I appoint my wife, Exie R. Lee, the executrix of this will and exempt her from giving bond as such executrix; I also exempt her from filing an inventory of my estate and from making settlement in any Court. I also authorize her to sell without an order of court, any of the property of my estate, real, personal and mixed, as she may deem best in the course of administration, as such executrix, EXCEPT the home place in Marion, Alabama, mentioned in paragraph 3 of this will, which may not be sold.
